Vendor Services Agreement with Lyndale Glass for the provision of labor, materials, equipment and supervision for the installation of a commercial storefront window on the existing counter at District Court. Compensation shall not exceed \$5,168 plus any applicable taxes. The Agreement shall commence on the date of execution and continue for three months.
- 10. Vendor Services Agreement with Lyndale Glass for the provision of labor, materials, equipment and supervision for the installation of five (5) commercial storefront windows on existing counters at the Auditor, Assessor, Clerk, Public Health and Treasurer Departments. Compensation shall not exceed \$69,494 plus any applicable taxes. The Agreement shall commence on the date of execution and continue for three months.
- 11. Amendment No. 1 to Vendor Services Agreement No. C20200227 with Woodwork Unlimited to provide all labor, demolition, disposal, materials, equipment for the fabrication of three (3) wood countertops and cabinets with all hardware and trim for the Skagit County Treasurer's office, Clerk's office and Sheriff's office lobbies. This Amendment increases compensation by \$5,750 for additional cabinetry work related to COVID-19 for the Hearing Room Courtroom Judges Bench areas. Total compensation shall not exceed \$19,550. The term remains the same and shall continue until February 15, 2021. All other terms and conditions of the original Agreement shall remain in effect.

d) **GEOGRAPHIC INFORMATION SERVICES**:

12. Amendment No. 4 to General Services Administration Federal Supply Schedule Contract No. GS-35F-0801N Agreement, Skagit County Contract No. C20160494, with Pictometry International Corp. for the purchase and licensing of Pictometry aerial imagery products. This Amendment modifies the 2021 project specifications for the third and final flight due to camera equipment improvements and reduces flight costs by \$1,925. Total compensation shall not exceed \$117,760. The term remains the same and continues through December 31, 2022. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

e) **INFORMATION SERVICES:**

13. Personal Services Agreement with Just Appraised Inc. to provide property transfer of ownership digital services for the County Assessor's Office. Compensation shall not exceed \$37,000. The Agreement is ratified to commence on July 1, 2020, shall continue until June 30, 2021, and will automatically renew on an annual basis for one-year terms until cancelled.

f) <u>PUBLIC HEALTH:</u>

14. Amendment No. 2 to Professional Services Contract No. C20180336 with Washington State Health Care Authority (HCA) for "Access to Baby and Child Dentistry (ABCD) Services, HCA Contract No. K2755, to detect and prevent early childhood dental decay by engaging dentists in seeing birth to six (6) year old Medicaid eligible children and engaging local public health departments in outreach and case management. This Amendment increases funds by \$56,000, adds definitions, updates the Scope of Work and Exhibits, and extends the term from June 30, 2020, to June 30, 2022. Total Compensation shall not exceed \$112,000. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

- 15. Personal Services Agreement with Chinook Enterprises to provide system navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation shall not exceed \$20,000. The Agreement shall commence on the date of execution and continue until July 31, 2021.
- 16. Personal Services Agreement with Community Action of Skagit County to provide rental assistance and case management services for homeless households and those at risk of becoming homeless. Compensation shall not exceed \$942,130. The Agreement is ratified to commence on July 1, 2020, and shall continue until June 30, 2021.
- 17. Personal Services Agreement with Rancho Alegre to provide additional food services for guests staying in isolation/quarantine at the Burlington Inn. Compensation shall not exceed \$10,000. The Agreement is ratified to commence on July 13, 2020, and continue until August 31, 2020.
- 18. Personal Services Agreement with Sherwood Community Services to provide system navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation shall not exceed \$20,000. The Agreement shall commence on the date of execution and continue until July 31, 2021.
- 19. Amendment No. 1 to Vendor Services Agreement No. C20190590 with Oliver Packaging & Equipment Company to provide dual oven/microwave meal trays and equipment to seal home-delivered meals. This Amendment increases compensation by \$75,001, for a new total amount not to exceed \$100,000. The term remains the same and shall continue through December 31, 2020. All other terms and conditions of the original Agreement shall remain in effect.
