- 21. Personal Services Agreement with Family Promise of Skagit Valley to provide diversion services, including one-time support, short-term services, and financial assistance to households who qualify for homeless services but can be diverted away from shelter and the homeless service system. Compensation is based on a reimbursement schedule and shall not exceed \$132,792. The Agreement is ratified to commence on July 1, 2025 and continue until June 30, 2026.
