- 6. Resolution declaring an emergency and waiving bidding requirements to purchase replacement LED drivers that were damaged during an emergency generator test at the Community Justice Center, located at 201 Suzanne Lane in Mount Vernon.
- 7. Resolution awarding the bid for the Commissioners Administrative Building Re-Roof Project to Hytech Roofing Inc. in the amount of \$502,500.
- 8. Resolution declaring an emergency and waiving bidding requirements to lease a temporary emergency generator while diagnosing the County's electrical power generating system at the Community Justice Center, located at 201 Suzanne Lane in Mount Vernon.

Compensation is based on a rate schedule and shall not exceed \$35,000. The Agreement shall commence on the date of execution and continue until December 31, 2022.
- 11. Vendor Services Agreement with Lyndale Glass to provide all labor, demolition, disposal, materials, equipment, and supervision for the installation of one (1) commercial glass window of the Skagit County Administration Building Courtroom located at 700 South Second Street in Mount Vernon. Compensation shall not exceed \$891.34 including applicable taxes. The Agreement shall commence on the date of execution and continue for four(4) months.
- 12. Amendment No. 1 to Vendor Services Agreement No. C20210271 with NC Power Systems to provide emergency generator equipment for the Criminal Justice Center located at 201 Suzanne Lane in Mount Vernon. This Amendment increases compensation by \$43,000 for a new total compensation amount not to exceed \$86,000, and extends the term of the Agreement to continue until October 9, 2021. All other terms and conditions of the original Agreement shall remain in effect.

d) INFORMATION SERVICES:

13. Amendment No. 5 to Agreement No. C20070313 with Cascade Software Systems to create software interfaces from Cayenta Financial System to the CAMS Maintenance Module. This Amendment updates the term to assist with migration from current WinCAMS Server to a new WinCAMS server. Compensation for the upgrade shall not exceed \$3,000 plus any applicable taxes. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

e) OFFICE OF JUVENILE COURT:

14. Personal Services Agreement with Pacific Northwest Guardian Ad Litem, LLC to coordinate Court-Appointed Special Advocate (CASA) program and provide CASA services for children who are the subject of an action in Juvenile Court under the Revised Code of Washington, Title 13. Compensation shall not exceed \$60,500 per

year and is based on a fee schedule. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2023.

f) PARKS, RECREATION AND FAIR:

15. Change Order #4 to Construction Contract Agreement No. C20210128 with Tiger Construction, LTD for the Pressentin Park Side Channel Restoration and Recreational Improvements Project #RCO 16-1730. This Change Order addresses work necessary to complete the ADA Gravel Surface trail located to the southeast of the new side channel between Bridge 1 and 2. Compensation is increased from \$1,853,183.81 to \$1,885,733.81. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

g) PLANNING AND DEVELOPMENT SERVICES:

16. Amendment No. 1 to Personal Services Agreement No. C20200104 with HDR Engineering, Inc. to assist staff by providing on-call planning services. This Amendment adds Task Assignment 1 for Water Availability Review from August 1, 2021, through October 31, 2021. Compensation is based on a rate schedule and shall not exceed \$35,563 for this Task. All other terms and conditions of the original Agreement shall remain in effect.

h) PUBLIC HEALTH:

- 17. Personal Services Agreement with Family Promise of Skagit Valley to provide Diversion services, including one-time support, short-term services, and financial assistance, to households with children who qualify for homeless services but can be diverted away from shelter and the homeless service system with immediate financial assistance. Compensation is based on a reimbursement for services schedule and shall not exceed \$60,000. The Agreement is ratified to commence on July 1, 2021, and shall continue until June 30, 2022.
- 18. Personal Services Agreement with Skagit Preschool and Resource Center (SPARC) to provide early intervention services for eligible infants and toddlers with developmental delays and their families living in Skagit County. Compensation is based on a reimbursement for services schedule and shall not exceed \$78,414. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2022.
- 19. Personal Services Agreement with Community Action of Skagit County to provide rental assistance and case management services for homeless households and those at risk of becoming homeless. Compensation is based on a reimbursement for services schedule and shall not exceed \$973,594. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2022.
- 20. Personal Services Agreement with Skagit Valley YMCA to operate the Oasis Teen Shelter program, seven days per week, every day of the year and for the provision of up to two (2) part-time staff, to include one (1) bilingual Spanish speaking staff, to work as interpreters at the Skagit County COVID-19 mobile vaccination sites, and other vaccine outreach related activities under the direction of Skagit County Public Health Staff. Compensation is based on a reimbursement for services schedule and shall not exceed \$76,627. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2022.
- 21. Agreement with Skagit Valley College Radio Station KSVR-FM for the purpose of providing radio announcements in English and Spanish to provide messaging regarding the COVID-19 Delta variant and vaccines. Compensation is based on a rate schedule and shall not exceed \$200. The Agreement is ratified to commence on August 2, 2021 and shall end after 40 announcements have been made or on September 30, 2021, whichever is later.
- 22. Personal Services Agreement with Sherwood Community Services to provide system navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation is based on a reimbursement schedule and shall not exceed \$15,000. The Agreement is ratified to commence on August 1, 2021, and continue until July 31, 2022.
- 23. Interlocal Cooperative Agreement with Sedro-Woolley School District to fund a school social worker in order to develop and support a Multi-Tiered System of Support (MTSS) practice and teams, increase capacity to implement or maintain programs and practices that reduce substance use and that target mental health promotion, prevention, and treatment, and to provide workforce development opportunities for district employees addressing behavioral, social and emotional determinants of health and learning. Skagit County shall reimburse the District an amount not to exceed \$70,000. The Agreement is ratified to commence on August 1, 2021, and continue until July 31, 2022.
- 24. Personal Services Agreement with Northwest Youth Services to operate the Skagit County Transitional Living Program and provide at least twelve (12) beds to homeless and runaway youth. Compensation is based on a reimbursement for services schedule and shall not exceed \$82,063. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2022.

- 25. Personal Services Agreement with Northwest Youth Services to provide Diversion services, including one-time support, short-term services, and financial assistance, to at-risk youth and young adults, 18-24 years old who qualify for homeless services but can be diverted away from shelter and the homeless service system with immediate financial assistance. Compensation is based on a reimbursement for services schedule and shall not exceed \$65,237. The Agreement is ratified to commence on July 1, 2021, and continue until June 30, 2022.
- 26. Amendment No. 1 to Interlocal Cooperative Agreement No. C20210036 with Washington State University (WSU) to provide Skagit County families with the Strengthening Families Program (SFP) for 10-14 year olds. This Amendment updates the "Purpose", "Responsibilities", and "Administration" sections of the Agreement to include the Guiding Good Choices Program (GGCP) for 8-12 year olds in the La Conner School District, adds a virtual attendance option, and updates the County's representative. Compensation remains at an amount not to exceed \$17,500. All other terms and conditions of the original Agreement shall remain in effect including the term, which shall continue until December 31, 2021.
- 27. Amendment No. 3 to Interagency Agreement No. K3940, Skagit County Contract No. C20190472 with Washington State Health Care Authority (HCA) to provide Community Wellness and Prevention Initiative coalition services in the communities of Concrete, Sedro-Woolley, and Mount Vernon, with the goals of preventing and reducing the misuse of alcohol, tobacco, marijuana, opioids, and other drugs. This Amendment updates outdated contract language, with no changes to overall scope and compensation and updates the term, which shall continue until September 29, 2021. Compensation remains at an amount not to exceed \$1,035,046. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

i) PUBLIC WORKS:

- 28. Resolution initiating the following County Road Projects (CRP): Hot Mix Asphalt (HMA) Overlay Project (2022), and Peter Johnson Road Railway Crossing Improvements Project.
- 29.
