Interlocal Cooperative Agreement with Port of Anacortes to award \$500,000 of Economic Development/Public Facilities Projects grant funds to support Curtis Wharf Corrosion Repairs and Cathodic Protection System. The Agreement commenced on July 13, 2020 per Resolution No. R20200120, and shall continue until January 31, 2022.

#### c) EMERGENCY MANAGEMENT:

8. Grant Agreement No. E20-263 with the Washington State Military Department and the U.S. Department of Homeland Security for Fiscal Year 2020 Emergency Management Performance Grant COVID-19 Supplemental (20EMPG-S) program to provide Federal funds to assist governments with their public health and emergency management activities supporting the prevention of, preparation for, response to, and recovery from the ongoing Coronavirus Disease 2019 (COVID-19) public health emergency. Compensation to Skagit County shall not exceed \$24,272. The Grant Agreement is ratified to commence on January 27, 2020, and shall continue through December 31, 2021.

# d) FACILITIES MANAGEMENT:

9. Vendor Services Agreement with Guardian Security Inc. to provide all labor, materials, equipment, and supervision for the AES Lease, Fire & Security Intrusion Alarm Monitoring Services at Skagit County Facilities. Total compensation shall not exceed \$50,000 plus applicable taxes. The Agreement shall commence on August 24, 2020, and continue until August 23, 2025.

#### e) HUMAN RESOURCES:

- 10. Personal Services Agreement with Assure Hire to perform professional employment and volunteer background checks. Compensation shall not exceed \$4,200. The Agreement shall commence on August 24, 2020 and continue until terminated.
- 11. Amendment No. 1 to On-Line Services Agreement No. C20140590 with GovernmentJobs.com, Inc. dba NEOGOV to provide a subscription, setup, implementation, and training to allow online job applications, announcements, descriptions, recruitment and exams for employment. This Amendment increases compensation by \$562.86 for the integration of an additional employment and volunteer background checks from August 11, 2020 through December 14, 2020. All other terms and conditions of the original Agreement shall remain in effect, including the term which automatically renews each year.

#### f) INFORMATION SERVICES:

- 12. Agreement with CDW Government LLC to provide assistance in setting up a Cisco AnyConnect VPN certificate authority for two factor authentication for all county assets accessing the county network. Compensation shall not exceed \$12,000. The Agreement shall commence on the date of execution and continue through December 31, 2020.
- 13. Agreement with NPDESPro, LLC for use of their stormwater permit tracking software to allow users to track compliance with the Phase II Municipal Stormwater Permit. Skagit County will pay an annual subscription fee of \$8,000 per year plus sales tax. Subscription fees are subject to an annual increase of up to 5%, in addition to increases or decreases in the annual fee based on the number of emails sent or subscription features. The Agreement shall commence on the date of execution and shall renew automatically until cancelled.

14. Amendment No. 1 to Subscription Agreement No. C20190427 with defender Data, LLC for the provision of software for a Public Defender Case Management System. This Amendment changes the Licensor from defender Data, LLC to Justice Works, LLC and increases compensation by \$3,000 for Uptrust Integration for the case management system. All other terms and conditions of the original Agreement shall remain in effect, including the term which ends September 30, 2022.

## i) PUBLIC WORKS:

Grant Agreement with the Washington State Department of Commerce through the Local and Community Projects Program, Community Assistance and Research Unit for capital expenditures related to the 16-Site Mixed-Mode Astro 25 Simulcast Upgrade for the Skagit County radio communications system. Compensation shall not exceed \$980,000. The Agreement is ratified to commence on July 1, 2019, and shall continue until June 30, 2023.
