Amendment No. 1 to Interlocal Cooperative Agreement C20180462, COA #IL267, with the City of Anacortes for the provision of Basic Life Support (BLS) Ongoing Training and Evaluation Program (OTEP) training in the "Anacortes Fire Department Training Hub" that includes training Fire Districts 11, 13, and 17 a minimum of 12 times per year for 2018 through 2024. This Amendment includes the addition of the Town of La Conner. All other terms and conditions of the original Agreement shall remain in effect.

c) PARKS, RECREATION AND FAIR:

6. RCO (Recreation and Conservation Office) Project Agreement with Washington State Recreation and Conservation Funding Board for the grant award to Skagit County in the amount of \$270,000 for the Skagit Valley Playfields-Artificial Turf Infields Project # 18-1531D. This project consists of updated synthetic surface fields, pitching mounds, and improved drainage on four (4) baseball/softball fields located at the Skagit Valley Playfields Complex, 2700 Martin Road, Mount Vernon. Skagit County shall contribute \$336,000, for a total project cost of \$606,000. The Agreement is ratified to the project start date of August 1, 2019, and ends on March 31, 2021.

- 7. Resolution authorizing litigation to abate a public nuisance by Exequiel and Guadalupe Quezada.
- 8. Personal Services Agreement with Perkins Coie LLP for the purpose of limited legal advice and representation related to tribal taxation matters. Skagit County is administrating the CDBG-funded Homeownership Assistance Project. This Amendment deobligates funds, officially closes out the project, and establishes a final loan repayment schedule. The original grant amount is decreased from \$750,000 to \$654,817.79. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect. The project completion date shall be June 30, 2019, and the loan repayment shall commence no later than June 30, 2020.

Compensation will not exceed \$15,000 annually. The Agreement shall commence on the date of execution and continue until terminated.
- 15. License and Services Agreement with Callyo 2009 Corp. to provide software license, maintenance, support and use of the Callyo website and software. Callyo is a unique cell phone technology communication system purchased pursuant to Skagit County Resolution No. R20190141. Compensation shall not exceed \$2,990. The Agreement is ratified to commence on August 1, 2019, and continue until July 31, 2020.
