### c) FACILITIES MANAGEMENT:

6. Vendor Services Agreement with Harris Pacific Northwest, LLC to install two new HVAC Coils to the air handler unit at the Skagit County Public Safety Building located at 600 South 3<sup>rd</sup> Street in Mount Vernon. Compensation shall not exceed \$31,554.18. The Agreement shall commence on the date of execution and continue until December 31, 2024.

#### d) HUMAN RESOURCES:

7. Amendment No. 1 to Personal Services Agreement No. C20240350 with ContoursFx for supplies and two artists to provide airbrush tattoos for three hours at the Skagit County All-Staff Summer Event. This Amendment updates the Scope of Work from three hours to three and a half hours and increases compensation from \$504 to an amount not to exceed \$588. All other terms and conditions of the original Agreement shall remain in effect.

#### e) INFORMATION SERVICES:

8. Resolution awarding the bid for Hewlett Packard Computer Hardware to Synchronous Technologies in the amount of \$280,017. The bid opening occurred on August 19, 2024.

## f) OFFICE OF JUVENILE COURT:

9. Interlocal Cooperative Agreement with Burlington-Edison School District to fund a BECCA Case Manager Position to help file truancy petitions, provide truancy intervention, and case management. Compensation shall not exceed \$17,766. The Agreement is ratified to commence on September 1, 2024 and shall continue through August 31, 2025.

#### g) PARKS AND RECREATION:

10. Vendor Services Agreement with VECA Electric and Technologies, LLC to provide parts, equipment and labor for the emergency electrical/utility pole replacement at the Skagit County Fairgrounds. Compensation shall not exceed \$60,000. The Agreement is ratified to commence on June 12, 2024 and continue until September 9, 2025.

### h) PUBLIC HEALTH:

- 11. Vendor Services Agreement with Rick's Refrigeration, Inc. to repair and replace defective parts of Senior Nutrition Program equipment. Compensation shall not exceed \$14,000 and is based on an hourly schedule. The Agreement is ratified to commence on July 1, 2024 and shall continue until September 9, 2025.
- 12. Interlocal Cooperative Agreement with Mount Vernon School District to fund a school social worker and a migrant health nurse to develop and support a Multi-Tiered System of Support (MTSS) practice and teams,

- increase capacity to implement or maintain programs and practices that reduce substance use and target mental health promotion, prevention, and treatment. Compensation shall not exceed \$103,000. The Agreement is ratified to commence on August 1, 2024 and continue until July 31, 2025.
- 13. Interlocal Cooperative Agreement with La Conner School District to fund a master's level school social worker to develop and support a Multi-Tiered System of Support (MTSS) practice and teams, increase capacity to implement or maintain programs and practices that reduce substance use and target mental health promotion, prevention, and treatment. Compensation shall not exceed \$73,000. The Agreement is ratified to commence on August 1, 2024 and continue until July 31, 2025.
- 14. Resolution authorizing Chair Browning to electronically sign the submission of Amendment No. 21 to Skagit County Contract No. C20210602 with the Washington State Department of Health (DOH Contract No. CLH31025) to increase funding by \$1,680,092 for a total contract amount of \$13,885,457 to support Public Health's programming.
- 15. Amendment No. 21 to Skagit County Contract No. C20210602 with the Washington State Department of Health (DOH Contract No. CLH31025) for the delivery of public health services in Skagit County. This Amendment adds and amends the Statements of Work for Public Health programs and increases compensation by \$1,680,092 for a total contract amount of \$13,885,457. The term remains the same and shall continue until December 31, 2024. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 16. Amendment No. 2 to Contract No. 243018-NUTR, Skagit County Contract No. C20240033, with Northwest Regional Council to provide meals and nutritional support through Congregate and Home Delivered Meals. This Amendment adjusts and increases compensation to Skagit County from \$456,322 to an amount not to exceed \$563,513 and extends the term of the Agreement to continue until December 31, 2024. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 17. Amendment No. 2 to Subaward Agreement No. C20220574 with Opportunity Council to provide three (3) individual efforts to address the disproportionate impacts of COVID-19 on households and communities in Skagit County. This Amendment replaces and Scope of Work and updates the reimbursement schedule. Compensation is reduced by \$354,354.28 and shall not exceed \$520,296.72. The term remains the same and shall continue until December 31, 2024. All other terms and conditions of the original Agreement shall remain in effect.

- 22. Amendment No. 13 to Grant Agreement No. C20230364 with the Washington State Conservation Commission (2023-25 Biennium Contract No. K2425) to continue implementation of the Voluntary Stewardship Program (VSP) plan work. This Amendment reallocates funding from Implementation to Technical Assistance for project Outcome #9 for Benson. Compensation remains the same and shall not exceed \$1,229,859.01. Compensation shall not exceed \$11,643.83. The Agreement is ratified to commence on May 15, 2024 and shall continue until June 30, 2025.

This Amendment adds a Zodiac Workboat to the Pollution Policy. Annual compensation is increased by \$338.07 for a new annual premium not to exceed \$147,656.07.
