IV. CONSENT AGENDA FOR MONDAY, SEPTEMBER 10, 2018 (items 1 through 9):

a) **BUDGET AND FINANCE:**

1. Resolution calling for a public hearing to amend the 2018 Skagit County Budget. The public hearing is scheduled to take place on Tuesday, September 25, 2018, at 11:00 a.m. in the Commissioners Hearing Room.

b) EMERGENCY MEDICAL SERVICES:

2. Personal Services Agreement with Rachel Mank, D.O. to provide assistance to the Skagit County Medical Program Director. Compensation shall not exceed \$90,430 and is based on a monthly fee schedule. The Agreement is ratified to commence on June 1, 2018, and shall continue until December 31, 2020.

c) PARKS, RECREATION AND FAIR:

3. Personal Services Agreement with Reid Middleton, Inc. to provide civil engineering services for the Skagit County Playfields (soccer fields) on parcel numbers P25048 and P25050. Compensation shall not exceed \$19,400 and is based on hourly rate schedule. The Agreement shall commence on the date of execution and continue until December 31, 2019.

d) PUBLIC HEALTH:

- 4. Personal Services Agreement with Phoenix Recovery Services to provide Criminal Justice Treatment (CJTA) eligible urinallysis testing, case management, and recovery support services to individuals referred for participation in the Skagit County Felony Drug Court. Compensation shall not exceed \$166,584 and is based on a rate schedule. The Agreement is ratified to commence on July 1, 2018 and continue until June 30, 2019.
- 5. Interlocal Cooperative Agreement with Conway School District for the purpose of providing a full-time, masters level, school social worker will equitably to serve both Conway and La Conner School Districts using the Multi-Tiered System of Support (MTSS) approach. Compensation shall not exceed \$81,000 and is based on a rate schedule. The Agreement is ratified to commence on September 1, 2018, and shall continue through June 30, 2019.

e) PUBLIC WORKS:

- 6. Resolution for the approval of plans and specifications and a call for bids for the 2019 Haul Out and Maintenance for the Vehicle and Passenger Ferry M/V Guemes, Project #FEHO19-1. The bid opening is scheduled to take place on Monday, October 8, 2018 at 1:00 p.m. in the Commissioners Hearing Room.
- 7. Vendor Services Agreement with Kamps Painting Company, Inc. for the installation of thermoplastic pavement markings at approximately 200 high-traffic locations. Compensation shall not exceed \$15,400. The Agreement shall commence on the date of execution and continue for one year.
- 8. Interlocal Agreement with Skagit Transit to perform work, provide materials and equipment upon request for roadway maintenance activities on a reimbursable basis. Reimbursement to either Skagit County or Skagit Transit will be for the actual cost incurred by the party as well as an additional 9% administrative fee. The Agreement shall commence on the date of execution and continue through December 31, 2024.

f) **SHERIFF**:

9. Personal Services Agreement Skagit County Critical Incident Stress Management Team (CISM) for the provision of critical incident stress management debriefing as needed. Compensation shall not exceed \$1,500 and is based on an annual rate schedule. The Agreement is ratified to commence on September 1, 2018 and continue until December 31, 2020.

- 1. Resolution for the approval of the submission of Amendments to the 2015-2017 Consolidated Plan, the 2016 Annual Action Plan and the 2017 Annual Action Plan.
