The Agreement shall commence on the date of execution and continue for six months. Compensation shall not exceed \$24,773.67.

Interlocal Cooperative Agreement with the Swinomish Indian Tribal Community concerning the assessment, collection and contribution of Swinomish Trust Improvement Use and Occupancy Taxes to Skagit County for transition related services, EMS services, and property taxes for improvements on fee land taxed by the Tribe. The Agreement shall commence on the date of mutual execution and continue until December 31, 2015. Swinomish Indian Tribal Community shall contribute \$90,000 to the County for Use and Occupancy Tax revenues, and \$52,957 to the County exclusively towards the Medic 1 budget and property taxes for improvements on fee land taxed by the Tribe.
