Personal Services Agreement with Sharon Fields, Attorney at Law, to provide indigent defense representation to defendants referred by the Office of Assigned Counsel, Superior Court, Juvenile Court and District Court who have been deemed conflict of interest for the Skagit County Public Defender's Office. Cases include Class A, Class B, and Class C felonies, homicides, dependency type cases, misdemeanors and gross misdemeanors for adults and juveniles. Compensation shall not exceed \$200,000. Northern State Recreation Area Trailhead and Park Project #RCO 18-1609. This Amendment updates the quantities of fill materials including Type A and Type B topsoil, and increases compensation by \$35,580 for the additional materials needed for both the trail and plaza area. Total compensation shall not exceed \$785,649.89. The term remains the same and shall continue until project acceptance. All other terms and conditions of the original Agreement shall remain in effect.

Compensation from Skagit County shall not exceed \$73,000. The Agreement shall commence on the date of execution and continue until July 31, 2023.
- 16. Interlocal Cooperative Agreement with Sedro-Woolley School District to fund a school social worker in order to develop and support the Multi-Tiered System of Support (MTSS) practice and teams, increase capacity to implement or maintain programs and practices that reduce substance use/disorders, that target mental health promotion, prevention, and treatment, and provide workforce development opportunities for district employees addressing behavioral, social and emotional determinants of health and learning. Compensation from Skagit County shall not exceed \$79,000. The Agreement shall commence on the date of execution and continue until July 31, 2023.
- 17. Interlocal Cooperative Agreement with Mount Vernon School District to fund a school social worker and a migrant health nurse in order to develop and support the Multi-Tiered System of Support (MTSS) practice and teams, increase capacity to implement or maintain programs and practices that reduce substance use/disorders, that target mental health promotion, prevention, and treatment. The purpose of the migrant health nurse is to provide mental health screening and community referrals, as appropriate, to eligible students. Compensation from Skagit County shall not exceed \$103,000. The Agreement shall commence on the date of execution and continue until July 31, 2023.
- 18. Agreement (Contract #MRC RISE 22-1027) with the National Association of County and City Health Officials (NACCHO) to provide resources to Skagit Medical Reserve Corps to support COVID-19 response by increasing capacity to Respond, Innovate, Sustain, and Equip (RISE). Compensation to Skagit County shall not exceed \$75,000. The Agreement shall commence on the date of execution and continue until December 31, 2022.
- 19. Amendment No. 1 to Personal Services Agreement No. C20220387 with New Earth Recovery to operate a Recovery Café located in the City of Mount Vernon and provide comprehensive recovery support services to individuals aged 16 and older who are working toward recovery from mental health, substance use, and co-occurring disorders. Amendment No. 2 to Skagit County Contract No. C20210608 with Organized Crime Drug Enforcement Task Forces (OCDETF) Investigation/Strategic Initiative Number PA-WAW-0343 for fiscal year 2022 to receive reimbursement for costs incurred by the Skagit County Sheriff's Office in providing resources to joint operations/task forces. This Amendment increases compensation to Skagit County by \$3,000 for a new total amount not to exceed \$8,250.30. The term remains the same and shall continue until September 30, 2022.
