b) **BUDGET AND FINANCE:**

12. Interlocal Cooperative Agreement with the City of Anacortes to assist in providing library materials to the residents of unincorporated Skagit County during 2019. Compensation shall not exceed \$14,457. The Agreement shall commence on the date of execution and continue until December 31, 2019.

c) **DISTRICT COURT PROBATION:**

13. Interlocal Cooperative Agreement No. IL286 with the City of Anacortes to formalize the relationship of the City and the County regarding the provision of probation services to the City. The City shall compensate the County \$50 for each month that a defendant is on active supervision up to a maximum of \$1,200 per defendant/case. In cases involving pre-sentence supervision, supervision of mandatory community service or determination of restitution, the maximum per defendant/case shall be \$150. The Agreement shall commence on January 1, 2020, and continue until December 31, 2022.

d) GEOGRAPHIC INFORMATION SERVICES:

14. Interlocal Technology Service Agreement with the Skagit County Drainage and Irrigation District Consortium, LLC to provide technical mapping services. Skagit County will be compensated for actual costs for services and a 15.6% rate for overhead. The Agreement shall commence on the date of execution and continue for three years.

e) PARKS, RECREATION AND FAIR:

- 15. Personal Services Agreement with Herrera Environmental Consultants, Inc. for the revised final design for the Pressentin Park Side Channel Restoration and Recreation Improvements Project. Compensation shall not exceed \$64,745, which includes all applicable taxes, and is based on a rate schedule. The Agreement shall commence on the date of execution and continue until December 31, 2020.
- 16. Vendor Services Agreement with D&D Construction, Inc., to remove all of the existing roofing materials and install a new roof on Building D at the Skagit County Fairgrounds. Compensation shall not exceed \$97,449.55, including all applicable taxes, and is funded by grant funds from the Washington State Department of Agriculture. The Agreement shall commence on the date of execution and continue for one year.

f) PLANNING AND DEVELOPMENT SERVICES:

17. Grant Deed of Conservation Easement per Skagit County Code 14.16.860, between G & D Wallace, Inc. (Grantor) and Skagit County (Grantee) to preserve and protect 28.3 acres of open farmland located on parcel numbers P21408 and P21452. No compensation is associated with this Easement. The Easement shall commence on the date of execution and continue into perpetuity.

g) PROSECUTOR:

- 18. Personal Services Agreement with Pacific NW Forensic Pathology, PLLC to provide expert witness evaluation, records review, and testimony in the area of forensic pathology for the prosecution in the matter of State of Washington v. Brett Grimnes, Skagit County Superior Court Cause No. 18-1-00228-29. Compensation shall not exceed \$7,500 and is based on an hourly rate schedule. The Agreement is ratified to commence on September 16, 2019, and continue until December 31, 2019.
- 19. Resolution to provide a defense to Skagit County Deputy Martin Kwant in a lawsuit filed by Keith Rawlins.

h) PUBLIC HEALTH:

- 20. Facility Use Agreement with McIntyre Hall Performing Arts and Conference Center for use of the facility for the Housing Summit on Tuesday, October 15, 2019. Compensation shall not exceed \$5,000.
- 21. Personal Services Agreement with Washington Vocational Services to provide "Pathways to Employment" and "Community Inclusion" services to eligible individuals with developmental disabilities. Compensation shall not exceed \$650,000, is based on a rate schedule, and is funded by Developmental Disabilities Administration Professional Services Funding. The Agreement is ratified to commence on July 1, 2019, and continue until June 30, 2020.
- 22. Personal Services Agreement with Answers Counseling to support perinatal mental health by providing support group services for parents and families experiencing Perinatal Mood and Anxiety Disorders. Compensation shall not exceed \$1,100, is based on a fee schedule, and is funded by federal Community-Based Child Abuse Prevention Funding. The Agreement is ratified to commence on July 15, 2019, and continue until December 31, 2019.
- 23. Personal Services Agreement with Chinook Enterprises to provide "Pathways to Employment" and "Community Inclusion" services to eligible individuals with developmental disabilities. Compensation shall not exceed \$650,000, is based on a rate schedule, and is funded by Developmental Disabilities Administration Professional Services Funding. The Agreement is ratified to commence on July 1, 2019, and continue until June 30, 2020.
- 24. Amendment No. 1 to Personal Services Agreement No. C20190075 with Side Note Consult, LLC to assist with the 2019 Skagit County Five-Year Homeless Housing Plan aimed at eliminating homelessness in accordance with Washington State Department of Commerce's guidance. This Amendment increases compensation from \$14,000 to an amount not to exceed \$18,000. The termination date remains unchanged and shall expire on December 31, 2019. All other terms and conditions of the original Agreement shall remain in effect.
- 25. Personal Services Agreement with Service Alternatives, Inc. to provide "Pathways to Employment" and "Community Inclusion" services to eligible individuals with developmental disabilities. Compensation shall not exceed \$200,000 and is funded through the Developmental Disabilities Administration Professional Services Funding. The Agreement is ratified to commence on July 1, 2019, and continue until June 30, 2020.
- 26. Personal Services Agreement with Skagit Preschool and Resource Center (SPARC) to provide early intervention services for eligible infants and toddlers with developmental delays and their families living in Skagit County. Compensation shall not exceed \$78,414 and is funded by Developmental Disabilities Administration Professional Services Funding. The Agreement is ratified to commence on July 1, 2019, and continue until June 30, 2020.
- 27. Amendment No. 1 to Personal Services Agreement No. C20190255 with Catholic Community Services to provide recovery services to individuals with substance use disorders. This Amendment decreases compensation from \$391,857 to an amount not to exceed \$371,250. The termination date remains unchanged and shall expire on June 30, 2020. All other terms and conditions of the original Agreement shall remain in effect.
- 28. Personal Services Agreement with Sherwood Community Services to provide "Pathways to Employment" and "Community Inclusion" services to eligible individuals with developmental disabilities. Compensation shall not exceed \$75,000 and is funded through the Developmental Disabilities Administration Professional Services Funding. The Agreement shall commence on November 1, 2019, and continue until June 30, 2020.

i) PUBLIC WORKS:

29. Resolution initiating County Road Projects (CRP) and establishing Fisher Creek at Starbird Road Culvert Replacement, the Fisher Creek at Cederdale Road Culvert Replacement, the Starbird Creek at Bulson Road Culvert Replacement and the Guemes Ferry Electric Shore-Side Facilities and Terminal Improvements.

30. Supplemental Agreement No. 5 to Local Agency Standard Consultant Agreement No. C20130621 with Shearer Design LLC to provide on-call structural engineering services for Skagit County projects. This Supplemental Agreement is amended to change the number of calendar days for completion of the work to read: The Time for Completion is amended to December 31, 2020. Compensation remains the same amount and shall not exceed \$350,000. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

j) SHERIFF:

- 31. Interlocal Cooperative Agreement with the La Conner School District to provide a presence of additional law enforcement personnel at La Conner School District Schools. Compensation to Skagit County shall not exceed \$70 per hour per deputy. The Agreement shall commence on the date of execution and continue until June 30, 2020.
- 32. Memorandum of Understanding (MOU) with the Washington State Department of Health (DOH), DOH Contract No. 24582, to provide DOH with access to Skagit County's incident report data on homicides, suicides, accidental firearm deaths, and deaths of undetermined intent for inclusion in the Washington Violent Death Reporting System (WA-VDRS). WA-VDRS is the state component of the Center for Disease Control and Prevention's (CDC) National Violent Death Reporting System. No compensation is associated with this MOU. The MOU shall commence on the date of execution and continue until terminated.
