Amendment No. 1 to Personal Services Agreement No. C20200689 with Consumer Voices Are Born to operate the REACH Center as the leading source of information for behavioral health, housing, and other ancillary resources and provide information to individuals with behavioral health disorders and their family members in Skagit County. Personal Services Agreement with Community Action of Skagit County to provide administration of the Tenant-Based Rental Assistance Program (TBRA) for individuals who have behavioral health disorders and to provide case management support for households receiving assistance through the TBRA Program. Compensation shall not exceed \$30,000. The Agreement shall commence on January 1, 2022, and continue until December 31, 2022.

c) PUBLIC WORKS:

- 4. Warranty Deed from Singletrack Mind LLC (Grantor) to Skagit County (Grantee) to grant a portion of Parcel No. P23346 to be used as public road right-of-way for the Francis Road Reconstruction Section 1 Project.
