Solid Waste Management Local Solid Waste Financial Assistance Agreement No. SWMLSWFA-2021-SkCoPW-00013 with the State of Washington Department of Ecology (DOE) to provide funding for Moderate Risk Waste Collection, Disposal and Outreach and Waste Reduction/Recycling-Public Education and Outreach. DOE shall provide 75% (\$384,499) in grant funding to Skagit County and Skagit County shall contribute 25% (\$128,166.33) for a total amount not to exceed \$512,665.33. The Agreement is ratified to commence on July 1, 2021 and continue until June 30, 2023.
- 22. Construction Contract Agreement with Coral Construction Company in the amount of \$529,450 for the Install/Upgrade Guardrail with Reflectors Project #ES07000-12; Federal Aid #HSIP-000S(578). The Agreement shall commence upon the date of execution and continue until completed.
- 23. Amendment No. 2 to Vendor Services Agreement No. C20190565 with Reisner Distributor, Inc. for Mobile Marine Refueling Services for the Vehicle and Passenger Ferry, M/V Guemes. This Amendment extends the term of the Agreement from December 14, 2021 to December 14, 2022 and increases compensation by \$125,000 for a new total not to exceed \$456,085.60. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

h) SHERIFF:
