The Agreement shall commence on January 1, 2023 and continue until December 31, 2024.

d) **BUDGET AND FINANCE:**

Amendment No. 3 to Interlocal Cooperative Agreement No. C20190334 with the City of Burlington to award \$430,000 of Economic Development/Public Facilities Project grant funds to support the arterial connection of Burlington Boulevard and South Walnut Street. In cases involving pre-sentence supervision, supervision of mandatory community service or determination of restitution, the maximum per defendant/case shall be \$150. The Agreement shall commence on January 1, 2023 and continue until December 31, 2025.

g) FACILITIES MANAGEMENT:

13. Standard AIA Form of Agreement with Alana, Buick and Bers, Inc. for the 4th Floor Demolition and Reroofing on the Skagit County Courthouse. Compensation shall not exceed \$362,720. The Agreement shall commence

on the date of execution and continue until project completion.

Amendment No. 1 to Personal Services Agreement No. C20220293 with Housing Authority of Skagit County to provide emergency shelter and tenant-based rental assistance to farmworkers and their families who are homeless or at risk of being homeless. This Amendment decreases compensation to an amount not to exceed \$28,361 and extends the term of the Agreement from December 31, 2022 to June 30, 2023. Conservation Credit Purchase and Sale Agreement between Puget Sound Partnership (Bank Sponsor) and Skagit County (Buyer) for the Guemes Ferry Electric Shore Side Facility & Terminal Improvements Project #ESMVGUE-2. The purpose of the Agreement is to provide for the purchase and sale of 105 conservation credits from the Puget Sound Partnership for a total cost of \$126,000. The Credit Purchase Form facilitates the process for federal permittees to purchase conservation credits from Puget Sound Partnership to offset Endangered Species Act (ESA) impacts resulting from the maintenance, replacement, expansion, or new construction of structures in the Puget Sound nearshore. The Agreement shall commence on the date of execution and continue until project completion.
- 31. Amendment No. 1 to Grant Agreement No. C20210413 with Washington State Recreation and Conservation Office (RCO) Project No. 20-1367P for the Debays Slough Feasibility Assessment to complete feasibility of reestablishment (fully or partially) of the hydraulic connection to the mainstem, including a detailed existing conditions assessment and 3-5 alternatives for restoration. This Amendment extends the term from December 31, 2023 to December 31, 2024. Compensation to Skagit County remains at an amount not to exceed \$161,500. All other terms and conditions of the original Agreement shall remain in effect.
- 32. Amendment No. 1 to Interlocal Agreement No. C20220059 with the Samish Indian Nation to participate in meetings and/or coordination with planning groups, stakeholders, agencies, and associations as it relates to or benefits the County's Clean Water Program within the Samish Watershed. This Amendment extends the term of the Agreement from December 31, 2022 to December 31, 2023. Compensation remains the same and shall not exceed \$24,000. This Amendment increases compensation from \$58,000 to an amount not to exceed \$66,000. The term remains the same and shall continue until December 31, 2024. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
