h) **INFORMATION SERVICES:**

- 21. Personal Services Agreement with Ivoxy Consulting, LLC to provide troubleshooting, configuration, architecture recommendations, software support, upgrade support for NetApp, VMWare systems, VEEAM software, and MS Exchange. Compensation is based on a fee schedule and shall not exceed \$30,000 plus applicable taxes. The Agreement shall commence on the date of execution and continue until December 31, 2021.
- 22. Personal Services Agreement with Handel Information Technologies, Inc. to provide report, configuration, interface and SQL table changes and other functions, outside of the law changes that are included in normal maintenance, as needed to assist Skagit County in the management and operation of the RiteTrack Case Management system installed at Skagit County. Compensation shall not exceed \$10,000 and is based on a rate schedule. The Agreement shall commence on the date of execution and continue until December 31, 2021.
- 23. Amendment No. 3 to License-Hosted Case Management Services License Agreement No. C20140277 with Probatum Technologies, Inc. for software license and support of the Probatum Case Manager system operated by Skagit County's Adult Probation Department. This Amendment increases compensation by \$600 per year to include one (1) additional Probatum License. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

i) OFFICE OF JUVENILE COURT:

The term of the Agreement shall be extended from December 31, 2020 to June 30, 2021. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 28. Amendment No. 1 to Personal Services Agreement No. C20190592 with Community Action of Skagit County to process mileage reimbursement requests for Skagit Meals on Wheels volunteers. This Amendment replaces Exhibit "B", Compensation, with Exhibit "B", Compensation Revised, increasing compensation from \$15,000 to an amount not to exceed \$17,000. All other terms and conditions of the original Agreement shall remain in effect including the term which shall continue until December 31, 2020.
- 29. Amendment A to Grant Agreement with the Washington State Department of Commerce through the Community Services and Housing Division Housing Assistance Unit, Contract No. 21-4614C-123, Skagit County Contract No. C20200448 to provide rent assistance for low income households to help prevent evictions. This Amendment increases compensation from \$1,412,932 to an amount not to exceed \$1,537,932. The Amendment is ratified to commence on November 18, 2020, and continue until December 31, 2020. All other terms and conditions of the original Agreement shall remain in effect.
- 30. Personal Services Agreement with Community Action of Skagit County for the provision of motel vouchers for homeless households that include an individual at the highest risk of complications from COVID-19. Compensation shall not exceed \$37,500. The Agreement is ratified to commence on December 1, 2020, and continue until December 31, 2020.
- 31. Vendor Services Agreement with UniFirst to provide and deliver gowns, as well as the pick-up and laundering of used gowns at the COVID-19 Testing Site, located at 501 Taylor Street in Mount Vernon. Compensation shall not exceed \$2,400. The Agreement is ratified to commence on November 1, 2020, and continue for one year.
- 32. Regional Insertion Order Agreement with National CineMedia, LLC to provide behavioral health promotion through digital marketing. Compensation shall not exceed \$3,000 and is based on a rate schedule. The Agreement shall commence on January 1, 2021, and continue until March 31, 2021.
- 33. Interlocal Cooperative Agreement with Washington State Department of Veterans Affairs (WDVA) to work collaboratively with the County to provide a full-time Skagit County Veteran Service Officer to identify the needs of clients and their families living within the County. The County shall reimburse WDVA an amount not to exceed \$60,000 which is based on the completion of the services and requirements specified in the Agreement. The Agreement shall commence on January 1, 2021, and continue until December 31, 2021.
- 34. Interlocal Cooperative Agreement with the City of Mount Vernon to set forth the duties between the City and the County regarding a law enforcement embedded social worker program that hires a social worker to provide outreach and engagement to enhance and assist in community support services to vulnerable populations. Skagit County will reimburse the City for services provided in the Agreement. Total reimbursement shall not exceed two-thirds (2/3) of the total cost of the program, for a total sum not to exceed \$60,000. The Agreement shall commence on January 1, 2021, and continue until December 31, 2021.
- 35. Vendor Services Agreement with Oliver Packaging & Equipment Company to provide dual oven/microwave meal trays and equipment to seal home-delivered meals. Compensation shall not exceed \$75,000. The Agreement shall commence on January 1, 2021, and continue for one year.
- 36. Personal Services Agreement with Sunrise Services, Inc. to provide outpatient substance use disorder treatment related services to Skagit County residents who meet eligibility requirements. Compensation shall not exceed \$15,000 and is based on an hourly rate schedule. The Agreement shall commence on January 1,

2021, and continue until December 31, 2021.

- 37. Personal Services Agreement with Sunrise Services, Inc. to provide mental health recovery services to individuals who meet the eligibility criteria with the primary goals of stabilization of problematic symptoms and/or behaviors, and the promotion of ongoing recovery. Compensation shall not exceed \$35,000 and is based on an hourly rate schedule. The Agreement shall commence on January 1, 2021, and continue until December 31, 2021.
- 38. Amendment No. 1 to Personal Services Agreement No. C20200498 with Catholic Community Services of Western Washington to administer the Eviction Rental Assistance Program (ERAP) Grant to prevent evictions by paying past due and future rent, targeting limited resources to those with the greatest need while working to distribute funds equitably. This Amendment increases compensation from \$395,360 to an amount not to exceed \$435,360. All other terms and conditions of the original Agreement shall remain in effect including the term which expires on December 31, 2020.
- 39. Amendment No. 1 to Personal Services Agreement No. C20200493 with Housing Authority of Skagit County to administer the Eviction Rental Assistance Program (ERAP) Grant to prevent evictions by paying past due and future rent, targeting limited resources to those with the greatest need while working to distribute funds equitably. This Amendment increases compensation from \$77,970 to an amount not to exceed \$158,220. All other terms and conditions of the original Agreement shall remain in effect including the term which expires on December 31, 2020.
- 40. Amendment No. 1 to Personal Services Agreement No. C20200495 with Pioneer Human Services to provide Criminal Justice Treatment Account eligible services to individuals referred for participation in the Skagit County Felony Drug Court. This Amendment updates the Scope of Work to include additional Recovery Support Services and increases compensation from \$100,000 to an amount not to exceed \$249,545. All other terms and conditions of the original Agreement shall remain in effect including the term which expires on June 30, 2021.

- 41. Amendment No. 2 to Interlocal Cooperative Agreement No. C20170471 with Skagit County Drainage District No. 21 to financially participate in the Turner Creek and Turner Creek Sediment Pond drainage conveyance improvement project. This Amendment increases compensation from \$150,000 to an amount not to exceed \$400,000. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect including the term which shall continue until October 16, 2023.
- 42. Interlocal Cooperative Agreement with Skagit Conservation District (SCD) to coordinate on the development, implementation and maintenance of water quality programs in Skagit County and to utilize the SCD to meet the goals of Skagit County's Shellfish Protection District, in accordance with RCW 90.72. Compensation shall not exceed \$263,000. The Agreement shall commence on January 1, 2021, and continue until December 31, 2021.
- 43. Personal Services Agreement with Skagit Watershed Council to assist Skagit County as lead entity for salmon recovery grant funding pursuant to RCW 77.85 and to coordinate with other member organizations to further salmon recovery in the Skagit Watershed. Compensation shall not exceed \$30,000, which is based on work performed or services rendered, labor, materials, supplies, equipment, and incidentals necessary to perform the work. The Agreement shall commence on January 1, 2021, and continue until December 31, 2021.
- 44. Personal Services Agreement with Maul Foster & Alongi, Inc. to provide consultation and support of the development of a long-range planning document (Plan) for the Natural Resources Division programs and activities. The Plan will include strategic goals, a mission statement, financial analysis of programs and activities, and recommendations for future funding sources for programs and activities. Compensation shall not exceed \$49,500. The Agreement shall commence on the date of execution and continue until December 31, 2021.
- 45. Escrow Agreement with U.S. Bank National Association to establish an escrow account to serve as the account for the Whitmarsh Landfill Settlement (Contract No. C20200013) funds from Shell Oil Company, Texaco, and the State of Washington Department of Natural Resources to be used to pay for the remediation of the Whitmarsh Landfill Site located in Anacortes.
- 46. Street Waste Facility Use Agreement with Whirlwind Services, Inc. dba Whirlwind Clean & Green to provide access to the Skagit County Waste Facility to dispose of waste generated from cleaning streets and stormwater drainage systems. Compensation shall not exceed \$60,000 per year and is based on a rate schedule. The Agreement shall commence on January 1, 2021, and continue until December 31, 2021.

o) <u>SHERIFF:</u>

- 48. Lease Agreement with Mt. Constitution Sites, Inc. for the lease of specified portions of a tower and space for equipment and property for the purpose of 2-way communications (repeater). The initial lease amount shall be \$350 per month. Compensation shall be adjusted annually by the Consumer Price Index. The Agreement shall commence on January 1, 2021, and continue until December 31, 2022.
- 2. Personal Services Agreement with Opportunity Council to utilize Opportunity Council as a subrecipient to administer the Tenant Based Rental Assistance (TBRA) program in Island County to provide tenant based rental assistance to low-income individuals and/or families who are homeless or at risk of becoming homeless. Skagit County will provide the subrecipient Opportunity Council with \$78,350.56 of HOME funding to implement the Consortium's TBRA program. The Agreement shall commence on January 1, 2021, and continue until December 31, 2022.
- 3. Amendment No. 1 to Personal Services Agreement No. C20200344 with Community Action of Skagit County to provide Emergency COVID-19 HOME Tenant Based Rental Assistance in Skagit County. This Amendment extends the term of the Agreement from December 31, 2020 to September 30, 2021. All other terms and conditions of the original Agreement shall remain in effect.
- 4. Personal Services Agreement with Community Action of Skagit County to provide HOME Tenant Based Rental Assistance (TBRA) for people with behavioral health disorders. Compensation shall not exceed \$30,000 and is based on an administrative rate schedule for the provision of the TBRA program. The Agreement shall commence on January 1, 2021, and continue until December 31, 2021.
- 5. Personal Services Agreement with Opportunity Council to utilize Opportunity Council as a subrecipient to administer the Tenant Based Rental Assistance (TBRA) program in Whatcom County to provide tenant based rental assistance to low-income individuals and/or families who are homeless or at risk of becoming homeless. Skagit County will provide the subrecipient Opportunity Council with \$121,087.37 of HOME funding to implement the Consortium's TBRA program. The Agreement shall commence on January 1, 2021, and continue until December 31, 2022.
