Interlocal Cooperative Agreement with Swinomish Indian Tribal Community to provide for the County to reimburse the Tribe for work performed by the Tribe on behalf of the County during an outage of the County's South Similk Beach pump during the winter of 2020. Compensation is based on reimbursement for work and rental of a temporary pump and shall not exceed \$4,326.75. The Agreement is ratified to commence on January 1, 2020, and continue until December 31, 2022.
- 36. Grant Sub-Award Agreement with Skagit Fisheries Enhancement Group (SFEG) for the award of \$7,383 for services related to the Skagit County Marine Resources Committee (MRC) operations and projects including Bowman Bay Restoration. The project is funded through an Agreement with the Washington State Department of Ecology, No. SEANWS-2021-SkCoPW-00003. The Agreement is ratified to commence on October 1, 2021, and shall continue through September 30, 2022.

- 37. Personal Services Agreement with Skagit Fisheries Enhancement Group (SFEG) to provide services in Skagit County to assist with the protection and improvement of water quality in saltwater shellfish growing and harvesting areas, consistent with the goals of the County's Shellfish Protection District, and in accordance with RCW 90.72. Compensation is based on a fee schedule and shall not exceed \$30,000. The Agreement shall commence on January 1, 2022, and continue until December 31, 2022.
- 38. Personal Services Agreement with Skagit Fisheries Enhancement Group (SFEG) to implement the on-going Natural Resource Stewardship Program (NRSP), Best Management Practice Program (BMPP), and other projects in accordance with the Natural Resource Division goals of improving water quality in saltwater growing and harvesting areas, consistent with the County's Shellfish Protection District, and in accordance with RCW 90.72 when utilizing Shellfish Protection District (Clean Water Program) funding. Compensation is based on a reimbursement schedule and shall not exceed \$100,000. The Agreement shall commence on January 1, 2022, and continue until December 31, 2024.
- 39. Amendment No. 1 to Vendor Services Agreement No. C20210206 with Acrow Corporation of America to purchase components to construct a clearspan 110-foot long 700XS Acrow Panel Bridge for the Concrete Sauk Valley Road (County Road #08000) near milepost 13 in Concrete. This Amendment increases compensation from \$200,000 to an amount not to exceed \$252,990.64 to accommodate the purchase of the parts and stamped plans to convert a 110' EW DSR2 configuration to a 130' DSR2 temporary bridge. The term remains the same and shall expire on April 26, 2022. All other terms and conditions of the original Agreement shall remain in effect.
- 40. Interlocal Cooperative Agreement with the Port of Skagit to work on a riparian planting and vegetation maintenance project located on Port property east and west of Higgins Airport Way. The primary purpose of this work is to establish native riparian vegetation along "Big Indian Slough" to benefit riparian enhancement. The County shall contribute a portion of the funds required for the Port's total cost of the project in a total amount not to exceed \$10,000.
- 41. Personal Services Agreement with Skagit Watershed Council to assist the County with administrative oversight and responsibilities as the lead entity organization for salmon recovery. Resolution authorizing Skagit County to apply for grant funding from Washington State Recreation and Conservation Office for four (4) projects: Barrel Springs and Dry Creek Restoration; Fisher Creek at Cedardale and Starbird Roads; Restoration Feasibility on Clark Creek; and Carpenter Creek at Cascade Ridge Design.

l) RISK MANAGEMENT:

Personal Services Agreement with Skagit Regional Health to provide occupational health services at Skagit Regional Health in order to comply with Washington State Department of Labor & Industries Department of Occupational Safety and Health and Washington Administrative Codes (WACs) related to blood borne pathogens, hearing conservation and respiratory protection as well as to manage risk related to fitness for duty. Compensation is based on a fee schedule and shall not exceed \$5,000. The Agreement is ratified to commence on December 31, 2021, and continue until December 31, 2022.
- 44. Personal Services Agreement with Bostec Inc. to develop and maintain a policy for employee training, on-site drug and alcohol testing and ensure compliance with the Department of Transportation regulations. Compensation is based on a fee schedule and shall not exceed \$5,000. The Agreement shall commence on January 1, 2022, and continue until December 31, 2022.

Interagency Agreement with the Washington State Department of Commerce (DOC) through the Community Services and Housing Division, Office of Firearm Safety and Violence Prevention Public Safety Unit DOC Agreement No. F19-31440-518 to purchase less than lethal equipment under the Less than Lethal Equipment Grant Program. Compensation to Skagit County shall not exceed \$47,317. The Agreement is ratified to commence on November 15, 2021, and continue until June 30, 2022.
- 46. Interlocal Cooperative Agreement with the City of Anacortes, City of Burlington, and City of Mount Vernon to purchase less than lethal equipment under a Washington State Department of Commerce (DOC) Grant Program. Compensation is based on a reimbursement schedule and shall not exceed \$34,166. The Agreement shall commence on the date of execution and continue until June 30, 2022.
