

RECORD OF THE PROCEEDINGS
SKAGIT COUNTY BOARD OF COMMISSIONERS

Wednesday, February 29, 1984

The Board of County Commissioners met in regular session on the above noted date. Commissioners Norris and Rohrer were present. Commissioner Mansfield was absent.

MISCELLANEOUS ITEMS

Robert Taylor, Commissioners' Assistant, presented the following items to the Board:

1. Chairman Norris approved for signature the bills and claims for Northwest Air Pollution Authority.
2. Commissioner Rohrer motioned to approve Warrants #925 through #926 in the amount of \$27,351.36. Chairman Norris seconded the motion. The motion was carried and so ordered. (C-12)
3. Commissioner Rohrer motioned to approve Warrants #726 through #842 in the amount of \$5,793.37. Chairman Norris seconded the motion. The motion was carried and so ordered. (C-10)
4. Commissioner Rohrer motioned to approve a Petition for Property Tax Refund for Lesta Parsons, 209 Haines, Sedro Woolley, WA 98284, in the amount of \$132.33 for 1982 and 1983. Chairman Norris seconded the motion. The motion was carried and so ordered. (Petition #844198)
5. Commissioner Rohrer motioned to deny a Taxpayer's Claims for Reduction of Assessments on Destroyed Real or Personal Property for Patricia A. Taylor, 809 Robinson Road, Sedro Woolley, WA 98284. Chairman Norris seconded the motion. The motion was carried and so ordered. (#554)
6. Robert Taylor presented the following Taxpayer's Claim for Reduction of Assessments on Destroyed Real or Personal Property:
 - a. Donald Hitt, 767 Medford Road, Sedro Woolley, WA 98284, in the amount of \$410.00 for the year 1984. (#553)
 - b. Margaret Harbeson, 202 Rainbow Drive, in the amount of \$700.00 for the year 1984. (#556)
 - c. F. J. Audette, 956 Chuckanut Drive, Burlington, WA 98233, in the amount of \$6,520.00 for the year 1985. (#558)

Commissioner Rohrer motioned to approve the above listed Taxpayer's Claims for Reduction of Assessments on Destroyed Real or Personal Property. Chairman Norris seconded the motion. The motion was carried and so ordered.

7. Robert Taylor presented the Board with a resolution calling for a public hearing regarding an amendment to the Skagit County Dog Control Zone Ordinance, Chapter 7.16, Skagit County Code. The amendment is necessary because the present ordinance is unenforceable as it now reads.

Commissioner Rohrer motioned to approve the resolution, "Call for Public Hearing, Amendment to Skagit County Dog Control Zone Ordinance, Chapter 7.16 Skagit County Code." Commissioner Norris seconded the motion. The motion was carried and so ordered. (Resolution #9981)

Commissioner Rohrer motioned to adjourn the proceedings. Chairman Norris seconded the motion. The motion was carried and so ordered.


