MISCELLANEOUS ITEMS

The Skagit County Board of Commissioners met in regular session on Tuesday, December 30, 1986, with Commissioners Vaux and Walberg present. Chairman Rohrer was absent.

1. RESOLUTION - SETTING OF LEVIES FOR ALL TAXING DISTRICTS.

Paul Mahoney, Skagit County Assessor, presented a list of tax levies for County taxing districts. He stated that there may be changes in the Sedro-Wolley and Anacortes School District levies, however, they could be amended later to reflect the change.

Commissioner Vaux motioned to approve the resolution setting the levies for all taxing districts in 1987, as recommended by the Skagit County Assessor. Commissioner Walberg seconded the motion. The motion was carried and so ordered. (Resolution #11104)

2. RESOLUTION - BUDGET LINE ITEM CHANGE

Commissioner Vaux motioned to adopt the resolution authorizing the transfer of budget appropriations in the amount of \$7,965.00 to provide for various expenditures not anticipated when the 1986 budget was adopted. Commissioner Walberg seconded the motion. The motion was carried and so ordered. (Resolution #11105)

MISCELLANEOUS ITEMS

1. The Board approved for signature a Dance Hall License for Robert Swanson and the Alger Tavern, 176 Old Highway 99 North, Bellingham. This license shall expire December 23, 1987.
2. Commissioner Vaux motioned to adopt the resolution authorizing the agreement which appropriates \$30,350 for 1987 to the Skagit County Community Action Agency to improve services to the County's low income residents. Commissioner Walberg seconded the motion. The motion was carried and so ordered. (Resolution #11106)



ADJOURNMENT


Commissioner Vaux motioned to adjourn the proceedings. Commissioner Walberg seconded the motion. The motion was carried and so ordered.




W. W. Vaux, Commissioner
