11:00 a.m. MISCELLANEOUS ITEMS

The Skagit County Board of Commissioners met in special session on Wednesday, December 31, 1986, with Commissioners Rohrer and Vaux present. Commissioner Walberg was absent.

MISCELLANEOUS ITEMS

1. Commissioner Vaux motioned to adopt the resolution establishing the legal paid holidays for County employees for the year 1987. Chairman Rohrer seconded the motion. The motion was carried and so ordered. (Resolution #11107)

It was noted that the County Clerk's, Superior Court and District Court Offices will observe Martin Luther King, Jr.'s Birthday on Monday, January 19, 1987, instead of Lincoln's Birthday, on Thursday, February 12, 1987.

2. The Board approved for signature an Agreement Release with Oeser Industries for fulfillment of a Timber Sales Agreement entered into on October 17, 1985.
3. In accordance with action previously taken, the Board approved for signature the resolution calling for a public hearing to consider authorizing a moratorium on aquaculture activities. (Resolution #11108)

This public hearing is scheduled for 7:30 p.m., Monday, January 19, 1987, in Hearing Room "C" of the Skagit County Administration Building.

4. Commissioner Vaux motioned to approve the following Petitions for Property Tax Refund, as recommended by the Skagit County Assessor and Treasurer:

- d. Woodworking & Design, c/o Arvo Kuure, 1201 5th, Anacortes, Washington 98221, in the amount of \$77.73, because the business was closed in February of 1984. (#012086)
- e. Continental, Inc., c/o Wayne Knopf, 408 Duffy Road, P.O. Box 57, Concrete, Washington 98237, in the amount of \$201.93, as ordered by the Board of Equalization. (#011786)

Chairman Rohrer seconded the motion. The motion was carried and so ordered.


