MISCELLANEOUS ITEMS

The Board met in session on Tuesday, April 7, 1987, with Commissioners Walberg, Vaux and Rohrer present.

DISCUSSION - FISCAL YEAR 1988 TIMBER SALES - MIKE NAYLOR AND JOHN OSBOURNE, DNR.

Mike Naylor handed out a report entitled Projection of Income from State Forest Board Lands and a number of timber sale applications and draft maps.

Mr. Naylor stated that income from state forest board lands in Skagit County has totaled \$4.8 million in calendar year 1986, including \$0.8 million returned as part of the 1981 suspense fund redistribution. Projected income for calendar year 1987 should total approximately \$3.3 million, a slight decrease from 1986, due to increased harvesting in late 1986 and increased value under contract for harvest after 1987. The next quarterly report will arrive in April 1987.

Commissioner Vaux inquired if they could give firm figures that could be used at the time the County did the annual budget. Mr. Naylor said unfortunately that was not possible because the loggers had up to two years to fulfill the contracts.

More discussion followed. The Board thanked Mr. Naylor and Mr. Osbourne for a fine report.

MISCELLANEOUS ITEMS


1. In accordance with action previously taken, the Board signed the resolution awarding the County Legal Printing bid. Resolution #11176
2. Commissioner Rohrer motioned to approve the following Petitions for Property Tax Refund as recommended by the County Assessor and County Treasurer. Commissioner Walberg seconded the motion. The motion was carried unanimously:
