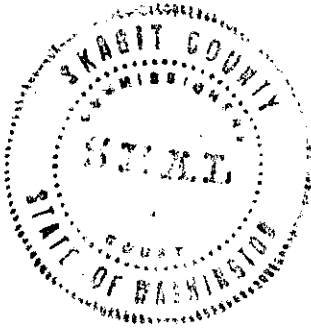


No members of the public were present for the public comment period.
