

**RECORD OF THE PROCEEDINGS  
SKAGIT COUNTY BOARD OF COMMISSIONERS**

**Thursday, September 13, 1990**

The Skagit County Board of Commissioners met in special session on Thursday, September 13, 1990, with Commissioners Ruth Wylie, W. W. Vaux and Dave Rohrer present.

**PROCLAMATION - D.A.R.E. DAY**

Sheriff Gary Frazier, Sgt. Joe Paque, Chief Criminal Deputy Larry Talbott and Deputy Kelly Howell of the Sheriff's Office were present to talk about D.A.R.E. Day with the Board. Gretchen Paque was also present. Commissioner Vaux read a proclamation proclaiming D.A.R.E. Day.

Sgt. Paque advised that D.A.R.E. started in Los Angeles 7 years ago. It is now in the entire U.S. and 7 other countries. He advised that he teaches D.A.R.E. classes in Burien and that his wife, Gretchen Paque, had the idea of spouse training for D.A.R.E. participants and provides training to spouses in Burien as well.

The Board thanked the D.A.R.E. participants present for their dedicated work.

**MISCELLANEOUS**

1) Commissioner Vaux motioned to approve voucher numbers 80606 through 80663 in the amount of \$16,785.00. Commissioner Rohrer seconded the motion, which was carried and so ordered.

2) Commissioner Vaux motioned to approve an Out-of-State Travel Request for Don King to attend an EPA Municipal Waste Incinerator Inspection Workshop in Atlanta, Georgia September 18 - September 21, 1990. Commissioner Wylie seconded the motion, which was carried and so ordered.

3) Commissioner Rohrer motioned to approve an Out-of-State Travel Request for Stephanie Nelson to attend a Northwest Users Group program on geographic data applications and the use of geographic information systems in preparation for using this type of system in the County, with particular attention to Planning Department applications. Commissioner Wylie seconded the motion, which was carried and so ordered.

4) A Contract for Field Inspection Services with Erwin Eerkes to provide services for the Planning Department was approved for signature.


