PUBLIC WORKS DEPARTMENT - MARK SPAHR, DIRECTOR:

Resolution - Citizens Solid Waste Advisory Committee Reports.

Jeff Monsen, Assistant Director - Solid Waste Division, presented a resolution to the Board appointing anew members to the Citizens Solid Waste Advisory Committee.

Commissioner Vaux motioned to adopt the resolution establishing the composition of the SWAC, establishing a one-year term for members, and appointing the following members:

2) Signature - C.R.P. - Lyman-Hamilton Road.

Commissioner Vaux motioned to adopt the resolution initiating County Road Project #9402-1, and authorizing preliminary engineering funds in the amount of \$15,000 for the drainage and widening of the Lyman-Hamilton Road from m.p. 5.39 to m.p. 6.91. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12687)

3) Out-of-State Travel Request.

Commissioner Vaux motioned to approve an Out-of-State Travel Request for Dave Sheridan of the Public Works Department to travel to Vancouver, British Columbia, to attend a seminar on Training and Development of Public Works Employees on November 5 and 6, 1990. Cost of travel was authorized at \$150.00. Commissioner Rohrer seconded the motion, which passed unanimously.

4) Miscellaneous.

- A. The Board approved for signature a contract for bare-boat charter of the Rimfire, a replacement vessel for the Guemes Ferry while it is undergoing its periodic maintenance. The contracting owner is Rope Nelson, who has agreed to the sum of \$525.00 per day charter fee. (Contract #00723)
- B. Mr. Spahr requested to speak individually with the Board regarding a request that Ed Hawes, a Public Works Department employee, be allowed to attend a specialized training to learn traffic accident reconstruction. Mr. Spahr stated that he believes it is necessary for his department to have the on-staff ability to perform traffic accident reconstruction. He stated that he at first was considering requesting that Mr. Hawes be allowed to attend a continuing engineering education program at George Washington University in Washington, D.C., in November; however, the transportation and tuition for the class would be quite expensive, probably over \$1,500. Mr. Spahr said that he will be looking into available alternatives for local training, and making a request at a later date.



Commissioner Vaux motioned to adopt the resolution calling for a public hearing on Wednesday, October 31, 1990, at 2:45 p.m., to consider a supplemental budget in the amount of \$57,880 for the Public Health Fund #101. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12694)
- B. Commissioner Vaux motioned to adopt the resolution calling for a public hearing on Wednesday, October 31, 1990, at 2:45 p.m., to consider a supplemental budget in the amount of \$14,490 for the Human Services Fund #116. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12695)
- C. Commissioner Vaux motioned to adopt the resolution calling for a public hearing on Wednesday, October 31, 1990, at 2:45 p.m., to consider a supplemental budget in the amount of \$2,300 for the Current Expense Fund #116. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12696)
- D. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12699)
- G. Commissioner Vaux motioned to approve a professional services contract with Rodney Watson of Marysville to provide periodic data processing programming and maintenance services at a rate of compensation of \$40.00 per hour, to continue from September 1, 1990, through December 31, 1990. Commissioner Rohrer seconded the motion, which passed unanimously. (Contract #00724)
- H. Commissioner Vaux motioned to adopt the resolution raising the amount of the Health Department's revolving petty cash fund from \$70 to \$150, and raising the amount of the four Health Department
