The Skagit County Board of Commissioners met in regular session on Monday, November 6, 1990, with Commissioners Ruth Wylie, W. W. Vaux and Dave Rohrer present.

PUBLIC WORKS DEPARTMENT - MARK SPAHR, DIRECTOR:

1) Signature - Francis Road Reconstruction Project: 1) Right-of-Way Plans b) Update C.R.P.

Mr. Spahr explained that the Francis Road reconstruction project will involve softening a curve which does not meet the current 35 m.p.h. minimum standards. In order to accomplish the softening of the curve, acquisition of additional right-of-way will be necessary. Mr. Spahr submitted forms and a resolution for signature which would authorize the acquisition of the right-of-way.

Commissioner Rohrer motioned to adopt the resolution authorizing right-of-way acquisition funds in the amount of \$7,000 for purchase of additional right-of-way for the Francis Road County Road Project #7900-2. Commissioner Vaux seconded the motion, which passed unanimously. (Resolution #12712)

The Right-of-Way Plans were also approved for signature.

2) <u>Signature - 1990-91 Winter Recreation Program Agreement with Washington State Parks and Recreation Commission.</u>

The Board approved for signature Contract #WR-90-91-ER-3 with the Washington State Parks and Recreation Commission for County forces to provide snow removal up to a \$500 maximum for the Shadow of the Sentinels Nature Trail, and up to \$350 maximum for snow removal on the Baker Lake Highway at Rocky Creek to facilitate snowmobile and winter recreation programs. (Contract #00728)

3) Signature - Amendment to Resolution #12686 - Citizens Solid Waste Advisory Committee Appointments.

Ric Boge, Recycling Coordinator, explained that a citizen recently appointed to the committee, Pat Lamphiear, has revealed that he will be unable to fulfill the obligations of the appointment and therefore resigns from the committee. Mr. Boge presented a resolution which replaces Mr. Lamphiear with Eric Hall as a non-voting member.

Commissioner Vaux motioned to adopt the resolution appointing Eric Hall to replace Pat Lamphiear on the Citizens Solid Waste Advisory Committee. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12713)

4) <u>Signature - Supplement No. 2 - Professional Services Contract for Resource Recovery Facility Landscaping.</u>

Jeff Monsen, Assistant Director - Solid Waste Division, updated the Board on the landscaping project at the incinerator. He stated that, as the project approaches winter shutdown, about 90% of the items included in area #1 are complete. Area #2 is entirely finished, and area #4 will be completed by the end of the week. Some items still remain in area #3, and the purpose of the Supplement No. 2 is to extend the contract to June 30, 1991, to allow the completion of those items after the winter shutdown.

Mr. Monsen also explained that of the \$50,000 budgeted for the project, \$35,000 has been used, and it is anticipated that the project's final cost will be approximately \$40,000 to \$50,000.

Commissioner Vaux suggested using the extra money to install grass outside the fenced perimeter all along the front to improve the aesthetics of the site. The other Board members agreed with this suggestion, and Mr. Monsen felt there would be enough money to accomplish this task. Mr. Monsen also felt there would be enough money left to permit the landscaper's suggestion to add additional trees to the screening. The Board also approved this suggestion. Finally, Commissioner Vaux suggested that the pavement lines inside the complex be repainted.

Commissioner Vaux motioned to approve Supplement No. 2 to the landscaping contract with Landscape Associates, to extend the time frame of the incinerator landscaping project. (Contract #00404)

- B. Commissioner Vaux motioned to adopt the resolution revising the County's Personnel Policies and Procedures Manual, Section 15.1a to include a description of the work week schedule for employees working at the Skagit County Incinerator. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12715)
- Jon Aarstad, Parks and Recreation Department Director, explained that additional evaluations are being required by the Department of Natural Resources in conjunction with appraisal of property at the Northern State. They feel that wetlands present on the land, the "Perpetual Park Clause", as well as the fact that timber must be valued for its aesthetics rather than current market value, will all effect the outcome of the appraisal. They require the addendum to the previously completed appraisal to be completed by November 16. Mr. Aarstad reported that McCauley and Associates, the firm that completed the appraisal, is able to accommodate this demand, and estimates a charge of approximately \$2,000. Mr. Aarstad requested permission to proceed with the work, having the contract amendment signed at a later date to save time.

Commissioner Rohrer motioned to approve the addition of the extra tasks described by Mr. Aarstad in the contract with McCauley and Associates for appraisal of lands at the Northern State, in an amount up to \$2,000. Commissioner Vaux seconded the motion, which passed unanimously.
