The Skagit County Board of Commissioners met in regular session on Monday, November 19, 1990, with Commissioners Ruth Wylie, W. W. Vaux and Dave Rohrer present.

UPDATE - FLOODING CONDITIONS.

Mary Margaret Haugen, State Representative; Bob Scofield, Skagit County Hearing Examiner and FEMA reservist; Mike Woodmansee, Budget/Finance Director; Jerry McInturff, Skagit County Auditor; and Judy Menish, Skagit County Treasurer were present for the discussion.

Bob Scofield, FEMA reservist, stated that the State Department of Community Development's Emergency Management team is gathering today to begin damage assessment to public facilities which will later be submitted to the Governor. The team that will assess private damage began its work on Friday, according to Jerry McInturff. These teams include representatives from the County's Emergency Management Department.

Mr. Woodmansee stated that FEMA representatives accepted private individuals' damage reports through Saturday; however, allowed Fir Island residents an extension on their reporting. These reports will be helpful in locating residences that require flood damage assessment by the DCD teams.

Mr. Scofield explained that special grants and low interest loans to repair flood damage will be in part based on the individuals' ability to pay for repairs. This factor will be important in determinations made at the disaster assistance centers that will be set up by FEMA if the President declares a disaster in Skagit County.

Mr. Scofield stated that it is being suggested at a number of informal gatherings of disaster coordinators that the relocation of the Town of Hamilton be discussed. This would require the condemnation of the land on which the town is currently located by the Hamilton Town Council. Mr. Scofield stated that FEMA may be convinced to provide financial aide for the relocation. Currently only those flooding victims who have flood insurance and have greater than 50% damage to their homes are eligible for a buy out of their holdings by the FEMA. Mr. Scofield stated that it is impossible to determine in what ways financial aide can be provided to those Hamilton residents without flood insurance. He stated that each case will be judged on an individual basis.

Mr. McInturff reminded the Board that other agencies and groups have loans or grants available to individual disaster victims.

Mr. Woodmansee reiterated that there are County personnel serving on the DCD assessment teams. He stated that the immediate concern of the Public Works Department at this time is the potential for another flooding disaster occurring over the coming weekend. Weather services are predicting a period of cold and snow down to low elevations, followed by another warming trend, winds and rain, which would hit Skagit County on Friday or Saturday, causing the potential for another flooding disaster.

Mr. Woodmansee also reported that a construction company engaged by Diking District #22 (Wilder Construction), which was working under contract to restore the sea dike near Fir Island, was prevented from beginning work on the sea dike early this morning by a representative from an unidentified State agency. Mr. Woodmansee stated that the Public Works Department is currently working to discover who halted the restoration, and how the situation can be remedied to allow Wilder Construction to proceed with the work.

Chairman Wylie reported that the dike breach had been reduced to three feet early this morning, and that the rest of the dike appears to be holding at present.

Mr. Woodmansee reported that Bob Taylor, the County's Administrative Officer, will be meeting with Public Works Department staff to make a decision on whether to go back on emergency staffing schedules in preparation for the predicted flooding conditions during the coming weekend. Mr. Woodmansee felt that the immediate actions of the County should be the shoring up of damaged and crucial dikes in preparation for more flooding.

The Board discussed with Representative Haugen and Mr. McInturff the possibility of dredging Skagit Bay for material to be used to repair the sea dike.

the Sheriff's Office to receive holiday premium pay when they have to work on a holiday. Mr. Taylor stated that he knows of no other temporary County employees who do not receive premium pay for work on holidays, and that this would ease the conflict between the provisional and full time employees in the Sheriff's Office over holiday pay.

The Board concurred with Mr. Taylor's suggestion, and Commissioner Vaux motioned to allow premium holiday pay for probationary Sheriff's Office employees who are scheduled to work on holidays, the policy to be effective September 1, 1990. Chairman Wylie seconded the motion, which carried and was so ordered.

ADJOURNMENT:

Commissioner Vaux motioned to adjourn the proceedings. Commissioner Rohrer seconded the motion. The motion was carried unanimously.
