

**RECORD OF THE PROCEEDINGS
SKAGIT COUNTY BOARD OF COMMISSIONERS**

The Skagit County Board of Commissioners met in regular session on Tuesday, November 20, 1990, with Commissioners Ruth Wylie, W. W. Vaux and Dave Rohrer present.

MISCELLANEOUS ITEMS.

- A. Dave Hough, Senior Planner, updated the Board on the Planning Department's activities relative to the flooding disaster. Mr. Hough provided a news release by the Planning Department which advertises assistance available to those reconstructing flood damaged homes and outbuildings. Mr. Hough provided a packet containing a building permit application, instructions, an application check list, a flood damage questionnaire, and a cost determination worksheet for substantial improvement and substantially damaged structures. Mr. Hough stated that the Planning Department plans to make these available at the Hamilton Post Office, Conway Fire Hall, Concrete Satellite Office, and Henry's Grocery. Mr. Hough also showed the Board signs which will be posted outside of potentially dangerous buildings by the Planning Department.
- B. Vouchers audited and certified by the auditing officer as required by R.C.W. 42.24.080, and those expense reimbursement claims certified as required by R.C.W. 42.24.090, have been recorded on a listing which has been made available to the Board.

As of this date, November 20, 1990, the Board, by a majority vote, did approve for payment those vouchers included in the above-mentioned list and further described as follows:

- 1) Manual Warrant #MW037-61968 in the amount of \$7160.45 (transmittal #C52-90).
- C. Commissioner Vaux motioned to adopt the resolution rescheduling the public hearing on the adoption of the 1991 Skagit County budget from December 3, to December 10, 1990, at 1:30 p.m., due to the disruption of the County's offices because of the flooding emergency. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12724)
- D. Paul Mahoney, Skagit County Assessor, reported on RCW 86.12.010, which is the County Flood Control River Improvement Fund section.


