Due to the flooding emergency, the agenda of the Board of Skagit County Commissioners for Tuesday, November 27, 1990, was canceled.

The Board did meet in an emergency session to consider a resolution submitted by the Public Works Department.


Commissioner Vaux motioned to adopt the resolution declaring that an emergency exists which requires that the extraction of rock quarry material from the Tewalt property be exempted from the State Environmental Policy Act, and authorizing the Public Works Department to begin development of a rock quarry located on the Tewalt property to provide rock for the immediate needs of flood control and repair that cannot be met by the existing County quarry. Commissioner Rohrer seconded the motion, which passed unanimously. (Resolution #12725)

Commissioner Vaux motioned to adjourn the proceedings. Commissioner Rohrer seconded the motion. The motion was carried unanimously.


