Executive Session - Personnel.

The Skagit County Board of Commissioners met in regular session on Monday, July 8, 1991, with Commissioners W. W. Vaux and Ruth Wylie present. Commissioner Robinson's absence was excused.

PUBLIC WORKS DEPARTMENT:

Introduction - New Staff Members - Katherine Holden and Jim Karcher, Engineering Division.

Katherine Holden, Design Technician, was introduced to the Board. Jim Karcher was unavailable and will be introduced at another time.

2) Presentation - Certificate of Commendation - July Recycler of the Month - Community Trades and Careers.

A Certificate of Commendation for July Recycler of the Month was presented to Community Trades and Careers.

Call for Public Hearing - Speed Limit Reduction on Portion of Sneeoosh Road.

Commissioner Wylie motioned to adopt the resolution calling for a public hearing on July 22, 1991, at 10:00 a.m., to consider a reduction in the speed limit on a portion of Sneeoosh Road. Commissioner Vaux seconded the motion, which carried and was so ordered. (Resolution #13056)

Signature - City/County Agreement - Cedardale Road.

The Board approved for signature Supplement #1 to Project #ER-90-11(154) with the Washington State Department of Transportation for asphalt overlay work on Cedardale Road. The total cost of the project was estimated at \$143,578.00, of which the Highway Department would fund \$123,513.00.

5) Signature - Rock Grant.

Commissioner Wylie motioned to adopt the resolution authorizing the award of 150 cubic yards of rock riprap valued at \$487.50 to Jeanne L. Woods to rip-rap approximately 100 feet of the Samish River near her home off of Prairie Road. Commissioner Vaux seconded the motion, which carried and was so ordered. (Resolution #13057)

6) Miscellaneous.

- Rich Medved, Interim Director of the Public Works Department, explained that the Skagit County P.U.D. #1 wants to extend a water line to service properties located on Britt Slough Road, where the County owns a small tax title parcel valued at \$600. The P.U.D. has proposed that the County's parcel be assessed \$4,560 for their share of a Utilities Local Improvement District. Mr. Medved stated that staff has sent the P.U.D. a letter objecting to the assessment which totals greater than the value of the property. Mr. Medved stated that two options exist if the P.U.D. insists on levying the assessment: To deed the property to the P.U.D., or to refuse to pay the assessment and allow the P.U.D. to take the property through foreclosure. The Board decided to await the P.U.D.'s response.
- Linda Johnson, Records Clerk, explained that Lexington Avenue is a private road located in the Plat of Fidalgo City. It serves as access for Buttram lane, which services an approved short plat obtained by Mr. Buttram in 1980. Mr. Buttram lives on Buttram Lane and is now beginning to develop other properties within his short plat. Since July of 1990, he has been requesting that Lexington Avenue be established as a County Road. Mr. Buttram reasons that he was required to build his private road to County road standards as part of his short plat approval, while Lexington Avenue is allowed to remain substandard. Review of Buttram Lane indicates that Mr. Buttram has not built his road according to short plat standards, although staff had actually signed off on his final plat some time ago.

Lexington Avenue itself is only about 30 feet wide and has been oiled and maintained by County forces, thereby seeming to establish prescriptive rights. County road standards require a 60 foot right-of-way. This would necessitate the purchase of 10 feet of land from property owners on the west of the road, and 20 feet from the eastern property owner. Although none of the adjoining property owners are in favor of establishing the road, the property owner to the east has indicated that if he is forced to sell, he would offer 15 feet of land.

Public Works staff does not favor the establishment. Mr. Medved indicated that no maintenance has been done on Buttram Lane for the 10 years it has existed, and Mr. Buttram should at least be made to perform 10 year maintenance on the road. In its present condition, the upper lots that are currently developing cannot provide safe access to emergency vehicles. Mr. Medved cautioned against establishing Lexington Avenue at less than a 60 foot width.

The Board judged that, since the County had indicated approval of Buttram Lane by signing off on the short plat, access should be provided, if possible via Lexington Avenue. Staff was directed to seek a legal opinion on the prescriptive rights claim, and to attempt to negotiate for the 15 to 20 feet of land from the eastern property owner.
