The Skagit County Board of Commissioners met in regular session on Monday, July 29, 1991, with Commissioners W. W. Vaux, Robby Robinson and Ruth Wylie present.

## **PUBLIC WORKS DEPARTMENT:**

1) <u>Public Hearing - Findings of Contract Negotiations Waste Management Northwest - Implementation of Joint Recycling Program.</u>

Ric Boge, Recycling Coordinator, explained that the public hearing is held in accordance with RCW 36.58.090, which requires that a public hearing be held whenever the County considers contracting with a solid waste vendor. Mr. Boge indicated that all participating cities have signed the interlocal agreement to formalize the joint recycling program, and have all signed the contract with Waste Management Northwest, indicating their approval.

Several questions were asked and answered:

- The contract indicates that annual adjustments to the price per ton paid to the contractor will be made at 80% of the Consumer Price Index. These adjustments may be either increases or decreases.
- Price adjustments will be made due to economic hardship. Economic hardship is defined as economic factors causing the contractor's income to decline by 50% or more during any continuous 12 month period. Should the contractor's income increase by 50% or more in any 12 month period, the County

may decrease payments to the contractor accordingly.

- The County will bill the participating cities based upon the tonnage received from each city, and the County will receive no administrative fees for the billing duties.

There was no comment from the audience, and Commissioner Wylie motioned to close the public hearing. Commissioner Robinson seconded the motion, which passed unanimously.

A contract with Waste Management Northwest will be presented for signature on August 12, 1991.

## 2) Discussion - Proposed Stream Stabilization Projects.

Dave Brookings, Flood Control Engineer, gave a presentation on creeks and streams which have potential for disturbing County roads during flooding season. Slides and photographs were used to illustrate the presentation. Which is summarized as follows:

Grandy Creek	2000'	\$100,000	Budgeted for 1991	Remove gravel and debris
Jackman Creek	3000'	\$156,000	This year	Remove gravel and debris. Countyassumed maintenance responsibilities in 1961 via a contract with Corps of Engineers at time of bridge construction.
Wiseman Creek	2700'	\$44,000	This year	Remove gravel to increase bridge clearance.
Red Cabin Creek	2000'	\$25,000	This year	Clean culverts and stream bed.
Muddy Creek	4200'	\$140,000	This year	Remove gravel to increase bridge clearance. No culvert replacement planned, although neighbor, Mr. Dynes, would like new culvert installed.
Childs Creek	1000'	\$13,000	This year	Remove gravel deposits.
Hansen Creek	4000'	\$80,000	Next year	Build sedimentation pond on Northern State property recently acquired. Used sub- flood control district annual funds of \$10-15,000 for maintenance.

> At the end of the presentation, Commissioner Wylie asked if the Department of Transportation could be approached to participate in any improvements. Mr. Brookings explained that the DOT refuses to become involved in any projects outside of their right-of-way. Furthermore, the Army Corps of Engineers is unwilling to participate in the largest project, the Jackman Creek improvement, because the nearby dike is not built to their standard.

> Chairman Vaux discussed with the audience an idea put forth earlier by Tom Studebaker after discussion with Art Stendal of the Fisheries Department. The idea is to place a culvert under the beaver dam which broke and flooded a number of Big Lake properties earlier this year. The beavers are unable to block the culvert, so water continues to flow through the creek. The Board asked Mr. Brookings to provide an estimate on this proposal.

> Mr. Brookings stated that, if given approval to proceed, the projects could be finished by September 15. According to Public Works accounting staff, the funds are available in an "Extraordinary Operations" fund, but would compete with other projects.

> The Board asked that Mr. Brookings provide more information on the Big Lake solution, and explain which Public Works projects would be competing for the funding.

## 3) Signature - Rock Grant.

Commissioner Wylie motioned to adopt the resolution awarding a rock rip-rap grant of 500 cubic yards of material to B.A. Strickland to rip-rap approximately 200 feet of the bank of Friday Creek on his property at 620 Old Highway 99. Commissioner Robinson seconded the motion, which passed unanimously. (Resolution # 13087)

#### 4) Establishment C.R.P. - Hickox Road Reconstruction Project.

Commissioner Wylie motioned to adopt the resolution initiating a County Road Project on Hickox Road, consisting of the reconstruction and improvement of 1.13 miles of roadway, and authorizing engineering funds in the amount of \$10,000 to begin the project. Commissioner Robinson seconded the motion, which passed unanimously. (Resolution #13088)

## 5) Call for Bids - Hickox Road Reconstruction Project.

Commissioner Wylie motioned to adopt the resolution calling for bids to be received and opened at 1:30 on Tuesday, August 13, 1991, for the completion of the reconstruction of Hickox Road. Commissioner Robinson seconded the motion, which passed unanimously. (Resolution #13089)

### 6) Update C.R.P. - Fir Island Road Construction Funds.

Commissioner Wylie motioned to adopt the resolution authorizing construction funds in the amount of \$196,518.23 for the repair of flood damage on the Fir Island Road. Commissioner Robinson seconded the motion, which passed unanimously. (Resolution #13090)

### 7) Update C.R.P. - Francis Road Construction Funds.

This item was deferred to next week.

## Miscellaneous.

A. Jeff Monsen, Assistant Administrator for the Solid Waste Division, related that at 2:00 a.m. on Sunday, July 28, 1991, the bottom ash conveyor belt on incinerator line #1 broke, shutting down the line. All parts are available on site for repair, but the line shutdown will necessitate a reduction in the incineration of wastes.

John Thayer, Supervisor of the Health Department's Environmental Health Division, indicated that the Department has a concern for the danger to public health that is inherent when wastes accumulate and are stockpiled during the repair. The Health Department recommended that wastes be temporarily diverted to the landfill for disposal until the repairs are completed. He indicated that a Special Use Permit may be necessary in order to accomplish this diversion, as the County Code indicates that the Inman Landfill may be used only for wastes other than putrescibles.

The Board discussed the possibility of diverting wastes out-of-county with Mr. Monsen. Finally, Commissioner Wylie motioned to declare an emergency session of the Board of Health to convene immediately, at 11:30 a.m. on July 29, 1991. Commissioner Robinson seconded the motion, which passed unanimously.

The Board immediately convened as the Board of Health. Commissioner Wylie motioned to declare the existence of a public health emergency under RCW 75.05.060 due to the failure of one line of the incinerator, and to allow the diversion of wastes from the County's Resource Recovery Facility to the Inman Landfill, to continue until all repairs are completed and both lines are again functioning, or until August 7, 1991. Commissioner Robinson seconded the motion, which passed unanimously.
