The Skagit County Board of Commissioners met in regular session on Tuesday, May 5, 1992, with Commissioners Robby Robinson, and Ruth Wylie present. Commissioner Vaux's absence was excused.

PLANNING AND COMMUNITY DEVELOPMENT - SCOTT KIRKPATRICK, DIRECTOR.

1) Signature - Additional Right-of-way Requirements for Short Plats.

Dave Hough, Senior Planner, presented to the Board a policy clarifying when additional right of way would be required in the agricultural zoned district. A list of roads were included which reflect those roads that have a potential of being widened some time in the future.

Commissioner Wylie motioned to adopt the policy requiring additional right of ways as required in short subdivisions for those roads within the agricultural zoning districts that may be necessary for the arterial or major collector roads as listed on the policy and as attached. Chairman Robinson seconded the motion, which carried and was so ordered.

2) Discussion - Comprehensive Planning Map Amendment Proposal 1992.

Jim Cahili, Assistant Planner reviewed with the Board applications received regarding owner initiated comprehensive plan map amendments for 1992. Twelve applications had been received from landowners to request comprehensive plan map amendments (CPAs). At the beginning of each year, individual land owners have a 60 day window of opportunity to file CPAs with the County. The total area. Comprehensive plan map amendments are made no more than once a year. Mr. Cahili stated that public use requests are allowed throughout the year and are not bound by the 60 day window.

Mr. Cahill stated the information is available for the Board to review or discuss further on any of the applicants.

Gary Christensen, Senior Planner, stated that the review process of the applications is being based on existing policies, as the Comprehensive Plan Maps are not due to be completed until July of 1993. Reviews of the applications will be made with maps and policies that are currently in place, evaluating the proposals with the Growth Management Act (GMA) in mind.

Mr. Christensen stated that the review process has been discussed with the applicants and how the GMA may affect their proposals.

Commissioner Wylle asked if the CMAs received in the February 1993 window would still be reviewed under the existing policies.

Mr. Christensen stated that the window for landowners to apply for CPAs will be from January 1 through February 28, 1993, which will be in the middle of the GMA improvements. There could be timing issues making it difficult to deal with those applications. In 1994, there may be requests received directly after adopting the Comprehensive Plan. It may be harder to obtain an amendment directly after the Comprehensive Plan is adopted.

3) Code Enforcement Activity Report.

The Code Enforcement Activity Report was presented to the Board.
