As of this date, August 18, 1993, the Board, by a majority vote, did approve for payment those vouchers included in the above-mentioned list and further described as follows:



ADJOURNMENT

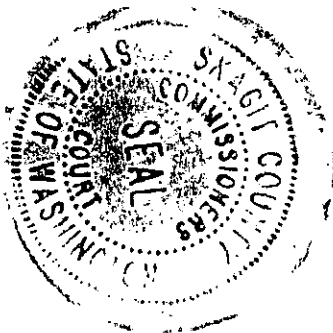
Commissioner Wolden motioned to adjourn the proceedings. Commissioner Robinson seconded the motion which carried unanimously.


