2:30 p.m. - 4:30 p.m. Executive Session - Personnel, Litigation and Land Acquisition.

The Skagit County Board of Commissioners met in regular session on Monday, March 28, 1994 with Commissioners Robby Robinson, Harvey Wolden and Robert Hart present.

DISCUSSION - SPACE NEEDS FOR SUPERIOR COURT (COURTROOM 2).

The Board met with Superior Court Judges Stanley Bruhn, George McIntosh and Michael Rickert, together with Court Commissioner Susan Cook, Pam Green and Facilities Director Roger Howard to discuss space requirements for Superior Court. Specific relocation plans during the Administration Office remodelling were briefly discussed.

Judge Bruhn expressed his concern that the remodelling is very short-sighted, and that Judge Rickert and Commissioner Cook are suffering from lack of space and private restroom facilities. Judge Bruhn further stated that there have been no improvements to the courthouse in 20 years, and that an additional courtroom is also required.

Bob Taylor, Administrative Officer, suggested that perhaps one of the hearing rooms could be converted to a courtroom as has been done in the past. This would afford considerable more privacy for Ms. Cook.

Several areas where additional space in the courthouse might be gained from rearranged quarters were discussed, and the general consensus was that short-term plans should not interfere with long-term

remodelling plans. Alternatives such as the Health Department Conference Room and the three hearing rooms were discussed.

Pam Green suggested that perhaps a solution to the restroom situation would be to install a key lock on one of the existing restrooms in the courthouse. Judge Rickert pointed out that the conversion of a hearing room to a courtroom would lack an adjoining chambers for attorney discussions and negotiations. Therefore, two hearing rooms would probably be required. Judge Rickert stated his reluctance to deprive the public of the use of these two rooms.

Commissioner Hart indicated the need to keep the lines of communication open as the quicker the problems are identified, the faster solutions can be reached.

Roger Howard, Facilities Director, stressed that any major remodelling to the courthouse will take 6-8 months to get started, and the group should concentrate on immediate solutions such as keying a restroom in the courthouse or rearranging existing space.

The Board indicated their approval for keying the restroom as discussed, and of getting the building footprint for review of possible remodelling potential and assessment of future needs.

DISCUSSION - ADMINISTRATION BUILDING REMODEL PROJECT.

Roger Howard, Facilities Director, advised the Board that, according to Code, if a building is classified as an "Essential Building", it would need to be designed to withstand a greater seismic load than regular buildings. Technically, the Administration Building does not qualify as an "Essential Building," and, according to the City of Mount Vernon, does not fit into the category of an Essential Facility. In order to bring the Administration Building up to the current seismic level for an "Essential Building," it would cost the County another \$500,000 in construction costs. The Mount Vernon planners are concerned that the Administration Building may be construed as an "Essential Building" by the general public, but in the course of the remodelling project, the Mount Vernon planners wanted the Board to know that they will not classify this building as an "Essential Building."

The Board concurred that the building need not be listed as an "Essential Building."

PUBLIC WORKS - Rich Medved, Director.

1. Public Hearing - Consideration of Parking Restrictions on a Portion of Lake Sixteen Road.

Commissioner Wolden opened the Public Hearing for comment. Steve Blair, Traffic Safety Investigator, reviewed with the Board a map of the area being considered for parking restrictions on a portion of Lake Sixteen Road. Mr. Blair advised that the road has little or no shoulder, and that trouble in locations such as this develop when people park on the roadway. Staff is recommending that both sides of Lake Sixteen Road be restricted to parking so there is adequate access for emergency service vehicles to get back into residential areas.

Ray Shulmier, resident of the Lake Sixteen area, stated that he had requested the parking restriction, but only intended the restriction to apply to one side of the road. The road is extremely congested during opening day of the fishing season through the first three weeks of the season. By completely restricting parking in this area, a great inconvenience would be created for fishermen during this time. Mr. Shulmier suggested that parking restrictions be imposed on the right-hand side of the road only and that keeping one

side clear will allow emergency vehicles to access the residences there. Commissioner Hart asked if there is any possibility for the Game Department to provide additional parking in the area. Staff advised that the Game Department has developed all of the property that they own at that location.

A discussion ensued on the pros and cons of restricting parking on only one side of the road and the blocked restriction of emergency vehicles. Mr. Blair clarified exactly where the proposed restriction would apply.

Joe Camblin, 2110 Lake Sixteen Road, asked for clarification of exactly where the restrictions would apply and expressed his feeling that the restrictions should be applied to both sides of the road.

Hazel Greenwood, a citizen in the area whose husband died last year while emergency vehicles were trying to pass through the blocked roadway, stated that she feels vehicles should be restricted from parking on only one side of the road.

Chairman Wolden indicated his concern that parking on one side of the roadway will still cause encroachment onto the roadway and will possibly be detrimental to emergency vehicles.

Libby Allen, Lake Sixteen resident, stated that the parking restrictions will further impact residents along Lake Sixteen Road by increased illegal parking in the residential areas.

Hearing no further public comment, Chairman Wolden moved to close the public hearing. Commissioner Robinson seconded the motion, which passed the unanimously.

Chairman Wolden expressed the need to reassess the merits of restricting parking on only one side of the road, thereby allowing the fishermen to park on one side, make a decision based on further review on which side of the road would be the best to restrict, arrange for signage, and see what happens. If it does not work, then Staff should come back and review the parking issue again.

Due to the essence of time, Doug Barnet, County Engineer, asked the Board to direct Staff to make the decision on which side of the road to restrict parking for this season, have Staff report back to the Board, thereby allowing the County to proceed with signage before the fishing season begins.

Commissioner Hart moved to do just as Mr. Barnet stated, and further for Staff to provide feedback after the first week of fishing season to apprise the Board on the results of the first few days of fishing season. Commissioner Robinson seconded the motion, which was unanimously passed.

2. <u>Signature - Interlocal Agreement Between Sedro Woolley Sub-Fisheries - Brickyard Creek Fish</u> Passage.

Dave Brookings, Public Works Staff, presented to the Board for signature an Interlocal Agreement By and Between the Washington State Department of Fisheries and Sedro Woolley Sub-Flood Control Zone titled "Brickyard Creek Fish Passage Agreement." This year the advisory board of the Sedro Woolley Sub-Flood Control Zone voted unanimously to use part of the Zone's budget to finance a fish passage design project with the Washington State Department of Fisheries. This agreement will be paid for by the Zone, and will cost \$14,000. The improvement will be constructed in late 1995.

Commissioner Robinson indicated his approval of this project, and moved to approve for signature the Interlocal Agreement as presented. The motion was seconded by Commissioner Hart, and passed

Signature - Interlocal Agreement with Washington State Department of Fisheries - Lorenzen Creek
 Fish Passage.

Doug Barnet, County Engineer, presented an Interlocal Agreement for signature between Skagit County and the Washington State Department of Fisheries titled "Lorenzen Creek Fish Passage Agreement" for the replacement of a culvert at Lorenzen Creek. This creek is located next to the Dalles Road just outside the Town of Concrete. This will replace an 18-inch culvert, which is unreachable to salmon, with a 72-inch culvert, at a cost to the County of \$62,500.

Commissioner Hart stated that this agreement is the result of intensive and extensive work done with the Department of Fisheries. Commissioner Robinson moved to sign the interlocal agreement with the Washington State Department of Fisheries. The motion was seconded by Commissioner Hart, and unanimously approved. (Contract #01988)

4. <u>Discussion - Request for Qualifications/Proposals for Annual Waste Stream Audits.</u>

Don King, Public Works Staff, informed the Board that the Department of Ecology has decided to enforce 173-306-200 WAC to identify amounts of toxic metals and other substances that contribute to the toxicity of the ash at the incinerator. This will be an annual procedure. Mr. King is asking for the Board's direction to issue a Request for Qualifications/Proposals for annual waste stream audits to be published. The RFQ/P is to receive letters of qualification and proposals for conducting these studies for Skagit County.

After brief discussion concerning this unfunded mandate by the State, it was estimated by Staff that this procedure will cost anywhere from \$50,000 to \$75,000.

The Board indicated their concern over the cost for this type of service, and queried Staff on the possibility of doing this report in-house. Staff indicated they would look into in-house assistance.
