The Skagit County Board of Commissioners met in regular session on Monday, December 19, 1994, with Commissioners Harvey Wolden, Robby Robinson and Robert Hart present.

PUBLIC HEARING - APPLICATION FOR COMMUNITY DEVELOPMENT BLOCK GRANT OF THE SWINOMISH TRIBAL COMMUNITY.

Paul Schissler, a Grant Proposal Writer, presented to the Board a copy of the proposed Community Development Block Grant. Mr. Schissler briefly discussed with the Board the need for development of water and sewer improvements along the West Shore area of the Swinomish Indian Reservation of Fidalgo Island. The grant would allow the County to receive Federal funding through the State to assist low-income residents which would, in turn, benefit the entire community. Mr. Schissler reviewed with the Board the definition of low-income limits for Skagit County households. The estimation is that between 70-80 households will apply and may be eligible based on their income and the fact that they own homes in the area. The application has been reviewed with John Petrish, the Director of the Swinomish Tribal Community, and Mike Woodmansee, Skagit County Budget/Finance Director.

Commissioner Hart questioned whether the BIA as a major property owner in the area pick up the



assessment, rather than the lessee living there. Mr. Schissler stated that households that lease land will qualify. Undeveloped property will not be eligible. Commissioner Robinson clarified that tenants will be able to demonstrate low income eligibility and thereby receive funds from this grant.

Commissioner Hart indicated that there are people in the area who are genuinely pressed financially to pay for these improvements, and stressed the need for the improvements for the sewer system in that regard. Commissioner Hart indicated the Board's support of the application.

Blair Painter, Shorewood Homeowner's Association, LaConner, asked for the Board's support on this application. Mr. Painter advised that this whole project has been a constant battle between people and government. Mr. Painter indicated that the original estimates were around \$3,500 per household and have escalated to \$8,000, and he is concerned that grant monies are generated by taxes that all citizens pay. Mr. Painter expressed his opinion that those people spending the taxpayer's money need to get things done reasonably and with a sensible approach.

Bo Miller, President of Westshore Tenants Association, briefly reviewed the situation in his area regarding the sewer/water assessment being levied against leaseholders, together with increases in rents. This grant is for 60-80 people in the area who are in dire need of such assistance. Mr. Miller concurred with Mr. Painter's remarks. This block grant will help those in need stabilize their lives, and feels this grant may assist those who may loses their homes.

John Petrish, who manages the Tribal utility department, verified that the numbers included in the grant application are correct and appropriate, and are fair and equitable based upon internal analysis and public comments. Mr. Petrish has worked with the Tribe and agrees that the project needs to be completed, and through the public hearing comments, a number of folks who live in the area they are concerned about the assessments and know that improvements are needed.

Commissioner Hart moved to close the public hearing. Commissioner Robinson seconded the motion, which passed unanimously.

Commissioner Robinson moved to approve the Resolution supporting the Application for a Community Development Block Grant for the Swinomish Tribal Community area. Commissioner Robinson noted that this is a good method of using tax dollars that can be returned to the community. Commissioner Robinson further noted that this is a competitive situation and there is no guarantee that the funds will be received. Commissioner Hart seconded the motion, which was unanimously approved. (Resolution #15581)

PUBLIC WORKS DEPARTMENT - Rich Medved, Director.

1. <u>Public Hearing - Consideration of Revision of Hours of Operation at the Resource Recovery Facility</u> (Transfer Facility).

Commissioner Wolden opened the public hearing. Brian Stephan, Public Works Department Staff, advised the Board of the proposed changes for the hours of operation of the transfer facility area. The proposed hours of operation are 8:30 a.m. to 6:00 p.m. on Wednesdays through Sundays. The public hours will be from 10:00 a.m. to 6:00 p.m. Mr. Stephan advised that the scalehouse will be open 7 days per week. Mr. Stephan further noted that these hours are reasonable for the general public due to the extension of evening hours past the normal work day.



Commissioner Robinson expressed concern for the difficulty in educating the general public to the new hours. A brief discussion ensued on this issue.

Mr. Stephan confirmed that the reduction in hours will not effect staffing levels.

Commissioner Wolden stated the importance of encouraging recycling and that employees assist the public in determining recyclables as they bring their garbage to the facility.

There being no further public comment forthcoming, Commissioner Robinson moved to close the public hearing. Commissioner Hart seconded the motion which passed unanimously.

Commissioner Robinson moved to approve the resolution regarding the establishment of operating hours of the Resource Recovery Facility (Transfer Facility). Commissioner Hart seconded the motion, which passed unanimously. (Resolution #15582)

2. Signature - Supplement No. 1 to Agreement with Snelson Refractory Services.

Mr. Stephan explained that this is a supplement for work done in March of this year. Mr. Stephan has questioned Snelson Refractory Services on the hours for this supplemental work, and subsequent adjustments were made. Mr. Stephan advised that originally this supplement was for \$15,000 and has been lowered to \$8,449.37. Mr. Stephan indicated that the estimated contract amount did not anticipate the additional work. The Board queried Mr. Stephan on the particulars of the extra work done to complete the chip out of refractory deemed structurally unstable and non-functional.

Commissioner Hart noted that to let something go 7-8 months that exceeded the budget amount is not acceptable. Chairman Wolden stated that Board should be contacted earlier in this regard to make adjustments more palatable. The Board indicated that they should be contacted for approval prior to the completion of such supplemental work.

Commissioner Robinson moved to approve Supplement No. 1 to the Agreement with Snelson Refractory Services by the amount of \$8,449.37. Commissioner Hart seconded the motion, which passed unanimously. (Contract #01979)

3. <u>Signature - Personal Services Agreement with Adolfson Associates, Inc. (Wetland Services - Fish</u> <u>Passage Projects).</u>

Dave Brookings, Surface Water Management Staff, presented a Personal Services Agreement with Adolfson Associations, Inc. for wetland reconnaissance on several fish passage projects to be constructed next June. The estimated cost is estimated at \$2,830.

Commissioner Robinson moved to approve the Personal Services Agreement as presented by Staff. Commissioner Hart seconded the motion, which passed unanimously. (Contract #02248)

4. <u>Signature - Resolution of Bid Award for One New/Demo 1994 Self-Propelled Highway Sweeper to</u> <u>Sahlberg Equipment Inc.</u>

Charles Tewalt, Public Works Department Staff, presented a Resolution awarding the bid for purchase of one new/demo self-propelled highway sweeper to Sahlberg Equipment, Inc. for the low bid of \$21,338.12. Mr. Tewalt briefly described the machinery.



Commissioner Robinson moved to approve the Resolution of Bid Award to Sahlberg Equipment, Inc. to furnish one 1994 Broce Highway Sweeper, Model RC300 for the bid price of \$21,338.12. Commissioner Hart seconded the motion, which carried unanimously. (Resolution #15583)

5. Signature - Supplement No. 5 to Agreement with Preston Gates & Ellis for Solid Waste Services.

Robin LaRue, Assistant Director of Public Works, advised that this contract supplement covers an hourly base to work at the Department's direction for legal items concerning the use of the incinerator. Mr. LaRue noted that a revised fee schedule is attached, and is not retroactive. Commissioner Hart moved to approve Supplement No. 5 to the Agreement with Preston Gates & Ellis for solid waste services. Commissioner Robinson seconded the motion, which passed unanimously. (Contract #01689)

- 6. <u>Miscellaneous</u>.
- A. Commissioner Hart questioned the Consent Agenda item for Parametrix, Inc. and Mr. LaRue briefly reviewed the scope of this item. Mr. LaRue advised that in-house staff will be doing this methane gas testing in the future. Parametrix will also complete some erosion work in addition to the methane gas testing. Much of the erosion work required will be charged back to the general contractor, Scoccolo Construction.
- B. Chairman Wolden questioned Staff on the Consent Agenda item of Supplement No. 3 to Ash Sampling and Analysis Services Agreement with Materials Testing & Consulting. Staff advised that this was a bookkeeping error and that additional work was required by the Department of Ecology for dioxin testing. Chairman Wolden noted the need to prepare such documentation and contract supplements expediently.
- C. Mr. LaRue shared with the Board a letter received addressed to Dave Brookings and John Abenroth thanking them for a culvert installed and expressing their appreciation for the fine workmanship of the maintenance crew.

EMERGENCY SERVICES - Dan Cain, Fire Marshall.

1. Signature - Resolution Establishing Pile Size and Burning Permit Fees for Written Burning Permits.

Dan Cain, Fire Marshall, stated that State Law mandates that a permit program must be set up or there will be no burning allowed. The proposed resolution is necessary to effectuate the changes made in the State law.

Commissioner Hart noted that the proposed schedule limits the days and times of burning.

Dan Mahar of the Northwest Air Pollution Authority briefly reviewed the specifics of the schedule and explained the window of opportunity for small brush disposal. This schedule will be uniform across the three counties of NWAPA's jurisdiction. Mr. Mahar cautioned changing the days and times as proposed as this would upset agreements previously set up with local fire jurisdictions.

Chairman Wolden stated that it is his understanding that the County should have had a public hearing regarding this type of ordinance so that people within the County are aware of what is happening and can provide input into the restrictions. Chairman Wolden clarified that this is a Resolution proposed by NWAPA. Chairman Wolden stated that for NWAPA to assume that a public hearing is not required, now puts NWAPA



in a desperate situation to get this Resolution approved and finalized. Chairman Wolden stressed that the people in Skagit County need to be consulted and that he is not ready to approve the Resolution at this point because proper channels have not been addressed.

Mr. Mahar stated that many fire districts have been consulted and that this schedule is strictly a recommendation by NWAPA. Mr. Mahar further noted that any kind of changes can be made as long as they adhere to WAC standards. Mr. Mahar indicated that this Resolution was prepared with the assistance of Dan Cain, the County Fire Marshall.

Mr. Cain stated that if the issue requires a public hearing, then that is what should be done.

A brief discussion ensued on the limitations this proposal would set.

Chairman Wolden asked Mr. Mahar to express to the Department of Ecology of the progress and concerns of the Board.

Staff advised that the public hearing on this matter will be held January 10, 1995 at the hour of 10:00 a.m.

2. <u>Signature - Memorandum of Understanding with Northwest Air Pollution Authority re: Outdoor</u> Burning.

In conjunction with the discussion above, the Board indicated they would consider the Memorandum of Understanding with Northwest Air Pollution Authority after the public hearing concerning outdoor burning.


