PUBLIC WORKS - Jan Keiser, Director.

1. Signature - Resolution Calling for Bids - Brickyard Creek Outlet Improvement Project.

Dave Brookings, Public Works Staff, presented the Resolution Calling for Bids on the Brickyard Creek Project. Mr. Brookings mentioned that bid opening would be on Tuesday, August 22, 1995, at 1:30 p.m.

Commissioner Anderson made a motion to approve the Resolution, as presented. Commissioner Wolden seconded and the motion passed unanimously. <u>(Resolution #15852)</u>.

2. <u>Signature - Right-Of-Way Plan - Bow Hill Road/Cedar Drive Intersection.</u>

James Kacher, Public Works Staff, presented the Right-Of-Way plans for signature on the Bow Hill Road/Cedar Drive intersection, stating that this is a traffic safety improvement project designed to improve sight distance at the intersection of Bow Hill Road with the private road, Cedar Drive. The Board signed the Right-Of-Way plans as presented.


3. <u>Miscellaneous.</u>

- Facilities:
 - 9. Personal Services Agreement with CDK Construction Services for the term of May 1, 1995, until terminated for the alterations to the Public Safety Building front entrance, glass security barriers at the reception areas of the Sheriff's Office, District Court Clerk's office, District Court Probation's office and Superior Court Clerk's office. Total compensation is not to exceed \$24,000 plus State Sales Tax. (Contract #02539).
- Human Services:
 - 10. Standard Work Order with DSHS Division of Children & Family Services. This Work Order and the previously signed Basic Contract contain all of the terms and condition for grant funding under DSHS's new contract conversion format. The Work Order extends payments to Skagit Community Mental Health Center for child abuse treatment services to members of the Swinomish Tribal Community for the period of July 1, 1995, through December 31, 1995, and is in the amount of \$4,361. (Contract #02540).
 - 11. Personal Service Agreement with Chinook Enterprises for the maximum amount of \$500,000 for the period of July 1, 1995, through June 30, 1996, for continuation of services for the developmentally disabled in Skagit County and funding is through grants from DSHS-Division of Developmental Disabilities. <u>(Contract #02541)</u>.
 - 12. Personal Services Agreement with Services Alternatives for Washington for the period of July 1, 1995, through June 30, 1996, for the maximum amount of \$250,000, for continuation of services to the developmentally disabled in Skagit County and funding is through grants from DSHS-Division of Developmental Disabilities offering community access/community integration services for adults. (Contract #02542).

2. Staff presented a Resolution providing a defense to Thomas J. Sheahan in Lawsuit by Bruce and Connie Grandy regarding a lawsuit, #95-2-00973-8. Chairman Hart made a motion to approve the Resolution, as presented. Commissioner Wolden seconded the motion and it passed unanimously. (Resolution #15854).



3. Staff presented a Personal Services Agreement on behalf of the Health Department, with Christine Kohnert, for the term of July 1, 1995, through June 30, 1996, to provide outreach services to target group women to promote their utilization of women's health services, including mammogram, and pap tests in the Breast and Cervical Health Program. The contractor will receive \$17,000 as total compensation. Commissioner Wolden made a motion to approve the contract, as presented. Chairman Hart seconded the motion and it passed unanimously. (Contract #02543).

PUBLIC DEFENDER'S OFFICE QUARTERLY REPORT.

Rob Jones, Public Defender, briefly reviewed the history of the Public Defender department. Mr. Jones reviewed the caseload figures within the department.

A discussion ensued in this regard.

Mr. Jones mentioned that while misdemeanor and juvenile cases are showing a slight decrease, the felony cases are increasing.

Mr. Jones commended the staff in the Public Defender's office.

Mr. Jones stated that the legislature has created an unfunded mandate (CHINS Bill) for the Public Defenders office to provide services to students in regard to truancy filings.

The Board concurred that quarterly updates were preferred.

PARKS DEPARTMENT - Jon Aarstad, Director.

1. Discussion - Park Board Appointments.

Jon Aarstad, Parks Director, mentioned that three individuals are up for replacement or reappointment on the Parks Board and all have stated that would like to serve for another term.

A discussion ensued.

Mr. Aarstad presented a Resolution appointing the three members until June 30, 1998. Commissioner Anderson made a motion to adopt the resolution, as presented. Chairman Hart seconded the motion and it passed unanimously. <u>(Resolution #15855)</u>.

- 2. <u>Miscellaneous</u>.
 - 1. Mr. Aarstad mentioned that in regard to changing the fair dates, as previously discussed, a Resolution was presented to change the dates for a one year trial period. Commissioner Anderson made a motion to establish dates of the 1996 Skagit County Fair as Wednesday, August 8th through Saturday, August 11th. Chairman Hart seconded the motion and it passed unanimously. <u>(Resolution #15856)</u>.
 - 2. Mr. Aarstad presented an Interlocal Cooperation Agreement with Skagit Valley College Community District No. 4 in regard to the Dreamfield project to accomplish the construction of a baseball and soccer field on property held by the State of Washington for the use of Skagit Valley College. The duration of the agreement is twenty (20) years, renewable June 30, 2015.

A discussion ensued.
