The Skagit County Board of Commissioner met in regular session on Wednesday, February 21, 1996, with Commissioners Ted W. Anderson, Harvey Wolden, and Robert Hart present.

PLANNING & PERMIT CENTER - REVIEW OF AND POTENTIAL ACTION ON GROWTH MANAGEMENT ACT ISSUES.

Chairman Anderson opened the meeting with a brief statement in regard to the Growth Management Act issues.

Commissioner Hart made a motion instructing the Prosecutor's Office to prepare and file an appeal of the Growth Management Hearings Board Finding of Non-Compliance and Finding of Invalidity Regarding Interim Urban Growth Areas (IUGA's) dated February 7, 1996, on the grounds that the Growth Hearings Board does not have constitutional or statutory authority to require the County to preclude urban development outside interim UGA's or authority to invalidate county zoning ordinances that were not adopted pursuant to GMA; and to instruct staff to prepare appropriate disclaimers regarding the pending legal issues and to begin processing permit applications on existing county development regulations, subject to applicant's acknowledgment of these pending legal issues.

Commissioner Hart also moved to instruct staff to evaluate several old ordinances potentially allowing higher densities in light of the concerns expressed by the Hearings Board and to bring a recommendation to the next Commissioner meeting regarding possible modification or repeal of those ordinances as further demonstration of the County's intent to comply with GMA.

Commissioner Wolden seconded the motion and it passed unanimously.

MISCELLAEOUS.

Vouchers audited and certified by the auditing officer as required by R.C.W. 42.24.080 and those expense reimbursement claims certified as required by R.C.W. 42.24.090 have been recorded on a listing which has been made available to the Board.
