The Skagit County Board of Commissioners met in regular session on Wednesday, September 18, 1996, with Commissioners Ted W. Anderson, Harvey Wolden and Robert Hart present.

**PUBLIC HEARING - CONSIDERATION OF AMENDMENT TO SKAGIT COUNTY CODE SECTION 15.20 - FLOOD DAMAGE PREVENTION ORDINANCE.**

Corey Schmidt, Planning, presented two attachments to the above referenced Ordinance, which included a staff report as Attachment A and Attachment B, which indicates the actual changes to the Ordinance. Mr. Schmidt briefly reviewed the staff report and the definitions accordingly, mentioning that 2(b) changed this to a year around policy rather than just during the flood hazard season from October 15 through March 15.

Chairman Anderson opened the Public Hearing.

There being no public comment, Commissioner Hart made a motion to close the Public Hearing. Commissioner Wolden seconded the motion and it passed unanimously.

Planning staff indicated that they will return to the Board with an Ordinance for signature as soon as possible to satisfy the Federal Emergency Management Agency compliance issue.

Commissioner Hart made a motion to adopt the Amendment to Skagit County Code Section 15.20 - Flood Damage Prevention Ordinance. Commissioner Wolden seconded the motion and it passed unanimously.

Chairman Anderson commended Mr. Schmidt on his perseverance on this issue.


**ADJOURNMENT.**
