The Skagit County Board of Commissioners met in regular session on Monday, December 16, 1996, with Commissioners Ted W. Anderson, Harvey Wolden and Robert Hart present.

DISCUSSION - AUDITOR'S OFFICE VOICE MAIL SYSTEM.

Kathy Hill, Auditor, explained that the voice mail system has assisted the Auditor's office by supplying five additional lines for customers to contact the Auditor's Office, as they were previously experiencing a busy signal when calling the Auditor's Office due to the lack of available incoming lines.

Ms. Hill discussed the volume of calls received in the Auditor's office and stated that customers who make an effort to come in for service at the counter get irritated when they are made to wait as the clerks answer incoming calls. Ms. Hill also reported that many people were being left on hold, when their questions could be answered if they were patient and listened to the recording. Ms. Hill reported that the recording and accounting departments have only a brief message and then a "real" person answers the call. Ms. Hill discussed the fact that there is not a receptionist or office manager in the Auditor's office to handle these calls and hoped to use the system to avoid making a request to the Board for additional staff. Ms. Hill reported that letters have been received in support of the voice mail system and provided copies for the Board to review.

Commissioner Hart questioned why the voice mail system provided the opportunity for five additional lines and further discussed the used of dedicated outside lines and other technical issues.

Ms. Hill stated that she has investigated the problems that were reported to her and that one of the things that seemed to be a problem is that County employees have not adhered to the new extension numbers that were provided via E-mail to every employee in the County. Ms. Hill stated that various extension numbers have been changed and this list is valuable in order to connect with the correct person. Ms. Hill also discussed a problem with "0" and "#" message and reported that she needs to talk to Ross Bailey in Maintenance about this problem. Ms. Hill briefly discussed the necessity to meet with Anna in the Health Department, Kathy in the Commissioners Office and Ross Baily, Maintenance, to try to resolve the current problems.

Ms. Hill requested a couple more weeks to resolve the problems with the voice mail system and stressed that it is also her intention to better assist the public. Ms. Hill emphasized that given a little more time to work the bugs out, the public would benefit.

Commissioner Wolden expressed his concern over the voice mail system and stated that the way the Auditors office is using this system is not the intended policy. A discussion ensued in this regard as to the ease or difficulty of voice mail.

Commissioner Anderson discussed the fact that this is a matter of efficiency, rather than personal preference, and further discussed the increase in counter activity which makes answering the phones more difficult.

Ms. Hill stated that she does not want poor customer service, however, reiterated that she would like a couple weeks to work out the problems in the system.

Commissioner Hart stated that this needs to be resolved expeditiously as possible.

Commissioner Wolden stated that he thought it would be a good idea to find out from the public what they would like in phone service.

Commissioner Anderson asked for a commitment on the Auditor's office part to either find an acceptable solution in COS couple weeks or dissolve the system as it is being used now.

The possibility of televising an educational program in regard to what services the Auditor's office provides was discussed and also the idea of using the plaid hot line to provide information to the public.

Commissioner Wolden stated that he is not satisfied with this request for additional time to resolve the problems, however, Commissioner Anderson and Commissioner Hart concurred that Ms. Hill should be given the opportunity for a couple of weeks to try to resolve the problems they are experiencing at this time.
