The Skagit County Board of Commissioners met in regular session on Monday, April 7, 1997, with Commissioners Harvey - Wolden and Robert Hart present. Commissioner Ted W. Anderson's absence was excused.

# PUBLIC COMMENT PERIOD.

Joanne Lennox, Concrete, spoke in regard to the natural resource land issues, specifically the secondary forest.

Leland Fox, Kelleher Road, Burlington, requested that the Board authorize the deelopment of a greenbelt along the road, comprised of easily grown trees, to screen the Butler gravel pit. Mr. Fox also addressed the Department of Natural Resource managed lands issues and commented on the courthouse foundation project, stating that he thought this money could have been spent more wisely.

Jim Grove, Anacortes, asked about the urban growth areas for Anacortes and wondered where this stands in the process right now. Commissioners Hart and Wolden discussed this issue with Mr. Grove.

Dan O'Donnell, Fire District No. 13, inquired about the Citizens Advisory Committee relating to the Public Participation Program.

- Sheriff:
  - 6. Amendment No. 1 to the Skagit County Sheriff Department Plantation Rifle Range Agreement (Contract No. 02847) with Whatcom County Parks & Recreation Department for the use by the Skagit County Sheriff Department for Plantation Rifle Range for the purpose of providing firearms qualifications for commissioned personnel. The County will have exclusive use of the Range on 20 days of each calendar year. The original agreement dated March 6, 1997, shall remain in full force and effect, except the Department shall pay a fee of \$5,464.20 including tax for the use of the range during 1997 based on 20 days for 71 officers. (Contract No. 02847).
- Planning:
  - Out-Of-State Travel Request for Bill Dowe to attend the PIBC & APA joint 1997 Planning Conference in Vancouver, B.C. Mr. Dowe will be attending only the 3<sup>rd</sup> day of the conference and the total cost will be \$20. (Approved).
  - 8. Personal Services Agreement with Woody's Typewriter Service beginning March 25, 1997, until terminated, for cleaning, service and repair on an as needed basis in the Planning & Permit Center. Compensation will be as outlined in Attachment A of the contract. (Contract No. 03444).
- Assigned Counsel:
  - 9. Personal Services Agreement with The Language Exchange, Inc. for the term of January 1, 997, until terminated, to provide court-certified or qualified interpreters in all languages for hearings and trials as requested by Skagit County Superior Court. Compensation will be in the amount of \$40 per hour for Spanish interpreters, \$50 per hour for American Sign, and an amount to be negotiated at time of requirement for some "exotic languages" with a two-hour minimum per appearance. (Contract No. 03445).
- Risk Management:
  - 10. Supplemental Agreement for Personal Services Agreement No. 03352 with The Evergreen Safety Council which was executed on January 21, 1997. All provisions in the basic agreement remain in effect except as related to scope of work and compensation, as follows: Contractor to provide additional safety training or safety consulting services on various topics as determined necessary and/or desirable by the Risk Management Department of the County. Compensation for additional safety training or other safety services to be agreed upon at the time the training or other services are explicitly defined. (Contract No. 03352).

  - 11. Call for Public Hearing regarding Consideration of Vacation of a Portion of Unopened County Right-of-Way known as Wood Road, #472. (<u>Resolution No. 16504)</u>.
  - 12. Resolution approving Interlocal Cooperative Agreement between the County and Dike District #4 and the Interlocal Agreement for reimbursable services for the period of five years. (Resolution No. 16505 and Contract No. 03447).
  - 13. Supplement No. 1 to Interlocal Agreement No. 03264 with Skagit Transit for the Park & Ride Facility at the west end of South March Point Road stating that the County will provide all necessary construction contract administration services and the estimated cost of the project is \$330,830, with the County's estimated inspection and construction contract administration cost is \$10,980 and the private contract work towards construction support and the Lease agreement addendum coordination with Texaco is \$5,147. All associated expenses and administration costs incurred by the County will be fully reimborsed by Skapit G Transit. (Contract No. 03264).
  - Supplemental No. 1 to Personal Services Agreement No. 03105 with Skagit Business Services which will allow Skagit Business Services to perform temporary clerical duties for Public Works until a full-time from desk of the assistant is hired. The revised contract total, inclusive of the original agreement is now \$9,000. Contract No. 03105).

Professional Services Contract with CH2M Hill, Incorporated, regarding Operation/Maintenance of Inman Landfill Methane Gas Extraction System to provide technical and field support for the operation and maintenance of the methane gas extraction system at the Inman Landfill. The total contract amount is \$2,000. (Contract No. 03448).

#### BID OPENING - LEASE OF LANDS FOR CATTLE GRAZING OR CROP FARMING.


Jon Aarstad, Parks Director, opened the bids received, as follows:
