Executive Session – Personnel, Litigation and Land Acquisition.

The Skagit County Board of Commissioners met in regular session on Monday, April 21, 1997, with Commissioners Harvey Wolden, Robert Hart and Ted W. Anderson present.

PUBLIC COMMENT PERIOD.

There were no citizens present for Public Comment today.

COMMUNITY HEALTH COUNCIL UPDATE.

Peter Browning, Health Department Director, discussed the assessment process regarding health status of communities and the state mandated requirements in this regard and reported that the Health Department is in compliance in most areas, however, it appears that we need to develop some community health councils. Mr. Browning stated they would like to develop a community health council to serve Burlington and Eastern Skagit County as the next step, as East County is under served as far as addressing personal health needs and environmental health issues. Mr. Browning asked for the Boards approval to proceed with the development of community health councils beginning in Burlington, moving toward East County, and then Mount Vernon/Conway.

Chairman Wolden inquired as to why we must develop these councils to provide out reach educational services when we already have a health department and other entities in place that provide this service. A discussion ensued in regard to this council being paralleled with services already provided. Mr. Browning stated this is the opportunity to take the information from the health department to the community. Chairman Wolden asked whether this could be accomplished another way, rather than developing a new council.

Commissioner Hart mentioned that there is not a history of support from the community for these types of councils. Commissioner Hart suggested several other alternatives to getting educational information to the community through programs already in place without the development of a newly established council. Commissioner Hart stated that this appears to be an implementation of developing more bureaucracy to protect certain jobs.

Chairman Wolden reiterated that there seems to be duplication in the process and discussed the real obligations and parameters of the Health Department.

Mr. Browning mentioned that the State mandates this program and stated that he would have to investigate the ramifications of non-compliance.

Commissioner Hart discussed the health survey done by Community Action and Head Start, stating that this included a compilation of very accurate information, as these entities are involved with out reach on a regular basis and a newly formed council would be duplicating this process.

Mr. Brown again discussed the procedure in which the council would educate the communities of their specific health needs and mentioned that Commissioner Hart's suggestions may fulfill the compliance issue and be just as successful. Mr. Browning stated that he would like to look at procedures other entities are using to comply.

A discussion ensued in regard to information that is being compiled by the Health Department, but is not in use.

Commissioner Hart read the proclamation into the record, proclaiming May 1, 1997, as Law Day 1997, and presented the proclamation to Cindy Tims, President of the Skagit County Bar Association.

The purpose of the Public Hearing is to determine whether a resolution shall be adopted authorizing a supplemental budget in the approximate amounts as follows: Land Acquisition and Facilities Fund #340 - \$860,000, Conservation Futures Fund #122 - \$378,687. Commissioner Hart made a motion to approve the Resolution, as presented. Chairman Wolden seconded the motion and it passed unanimously. (Resolution No. 16517).
