8:00 a.m. – 9:00 a.m. Discussion and Possible Adoption of Interim Ordinance Implementing the Comprehensive Plan.

The Skagit County Board of Commissioner met in regular session on Thursday, May 29, 1997, with Commissioners Harvey Wolden, Robert Hart and Ted W. Anderson present.

DISCUSSION AND POSSIBLE ADOPTION OF INTERIM ORDINANCE IMPLEMENTING THE COMPREHENSIVE PLAN.

Gary Christensen, Senior Planner, reviewed with the Board the changes to the proposed Interim Ordinance to Implement Comprehensive Plan. Mr. Christensen explained that most of the changes were grammatical or typographical. A page-by-page review of the document ensued with particular emphasis on the red-lined additions and other changes.

Commissioner Anderson noted the importance of advising the public of the July 31, 1997 deadline for notifying the County of purported improper land use designations. Mr. Christensen indicated that every effort would be made to notify the public.

It was noted that this ordinance will become effective June 1, 1997 and shall remain in force and effect for a period of 12 months unless amended or repealed.

Commissioner Hart expressed the need to have a comprehensive list of those individuals who have submitted improper land use designations so the public can ascertain if they have submitted the necessary documentation.

Commissioner Hart moved to adopt the Interim Ordinance to implement the Comprehensive Plan as presented. Commissioner Anderson seconded the motion, which passed unanimously. (**Resolution No. 16559**)

Chairman Wolden expressed the Board's thanks to the citizens advisory committees and planning commissioners and other individuals in developing the Comprehensive Plan.

Jay Derr, Attorney, noted that a brief asking for the lifting of the order of invalidity from the Growth Hearings Board Ruling would be filed forthwith.

MISCELLANEOUS.

Staff presented the Plat of Sunset Creek Planned Unit Development for the Chairman's signature.

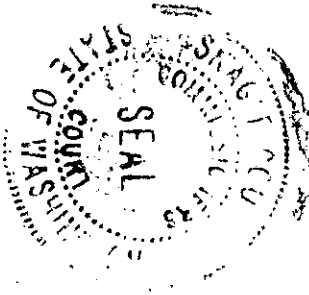
