The Skagit County Board of Commissioners met in regular session on Tuesday, July 6, 1999, with Commissioners Ted W. Anderson, Harvey Wolden and Robert Hart present.



Appeal of the Health Officer's Decision regarding On-Site Sewage Permit #\$99-0016 (Jerry 1. & Virginia Scheffer, d/b/a Anaco Beach Guest Suites Inn).

Tom Mosher, 411 Main Street, Mount Vernon, stated that he is an attorney representing 27 families in the Marine Drive area on the West Side of Fidalgo Island. He reviewed a drawing of the area showing where his clients live and where the site at issue is located. He stated that a packet of materials had been presented to the Board on Friday, and added additional items consisting of an attachment to a report from Transportation Solutions, Inc. containing technical detail about Marine Drive, and a resume from James Carr, a hydrogeologist who would be testifying later in the proceedings.

Mr. Mosher explained that the decision of the Skagit County Health Officer was appealed because the appellants feel the conditions of the permit were not sufficient. The issues in question consist of a failure to determine whether this is a commercial or residential application, failure to find that the aerobic treatment system will produce odors, and the failure to require the applicant to meet existing hydraulic loading requirements, and additional concerns. He stated that of primary importance for the Board's consideration is that the applicant is not intending a single family residence at the site, but rather a bed and breakfast facility. Mr. Mosher stated that this is a commercial establishment, as evidenced by an application for a special use permit, website, toll free phone number, and on-site manager. Mr. Mosher indicated that the Health Officer did not consider these facts, as he felt these are zoning issues, not septic permit issues. Mr. Mosher stated that this is important as size of the septic system would have impact on the drainfield and adjacent property owners.

Jim Carr, AGI Technologies, stated that he is a hydrogeologist, who has worked professionally in the field of water supply for 30 years, and has done a number of projects along Marine Drive. He stated that he





was retained by Mr. Mosher to review effluent issues raised by this proposed bed and breakfast. Mr. Carr indicated that the site was reviewed in April, as well as documents provided by the applicant and Skagit County. He stated that the Environmental Protection Agency estimates that 30% of drainfields and effluent disposal systems fail because existing regulations are not followed precisely. Mr. Carr stated that Skagit County has a good set of codes for septic tank and effluent disposal, and, if followed, would not pose a problem. He indicated, however, that there could be problems due to the lack of conditions placed on the septic permit.

First, Mr. Carr explained that the existing drainfield is not of adequate size and needs to be at least 750-900 square feet to accommodate the number of bedrooms and people in the bed and breakfast. He commented on the Health Officer's letter being incorrect in that the aerobic treatment unit allowed the doubling of the disposal rate. He noted the wet season issue, stating that no evaluation had been performed during the wet season and that most failures are caused by drainfields becoming saturated, which allows effluent and nutrients to flow to the subsurface and cause odors. He noted that the site is on a steep slope, and he reviewed photographs of the proposed drainfield area. Mr. Carr questioned the appropriate setback for a drainfield, and noted that there is no provision in the application for a reserve area drainfield. He stated that, in his opinion, effluent will discharge downhill into the neighboring interceptor drain.

Duane Knapp, 11168 Marine Drive, an adjacent property owner, spoke on behalf of 32 neighbors who have signed petitions against this development. He stated that he and the neighbors are mystified as to why they should have to come before the Board when the regulations that the County has are not being followed. He stated that the septic permit should not have been issued. He commented on the need for a wet season review, together with consideration of the steep slopes in the area. He indicated that the driveway of the subject home is so steep that it was been deemed to be unsafe by the local fire chief should there be a fire. Mr. Knapp stated that the State Health Department says they do not recommend these types of devices. He questioned if the Health Officer had in fact visited the site and reviewed the unusual situation there. He summarized by saying that to conditionally approve this when there has been no wet season review is significantly deficient.

Al McCrary, 11064 Marine Drive, a neighbor to the project located two lots north, stated that he is an engineer. He commented on the need to consider the amount of laundry a bed and breakfast would be processing, and noted that the daily load for the septic system would be greatly impacted compared to a residential load.

Joel Haggard, 1200 IBM Building, Seattle, stated that he is an attorney representing the applicants, Jerry and Virginia Scheffer. He emphasized that the appeal before the Board is of the septic permit for residential use as reviewed by the Skagit County Health Officer. This is the only issue before the Board, not the potential for a bed and breakfast establishment. He stated that the applicants firmly disagree with the appellants in their characterization that the Health Officer did not look at his own regulations and visit the site. He stated that Staff was not arbitrary and capricious but carefully considered the facts. Mr. Haggard indicated that there was a concern throughout the proceeding about the bed and breakfast, which is a land use matter. He stated that he objected to the exhibits lettered A, B, F, G, H, L, N, O, R, S, and T, because they have either unsworn facts, incompetent facts, or are not material or relevant to this appeal. Mr. Haggard stated that he received appellant's packet of materials at about 8:50 a.m. this morning, and is therefore raising objections to the exhibits as stated. He expressed his concern in not being able to cross-examine the technical expert of the appellants, but indicated that his expert, Mr. Smith, would address the primary concerns of setback, wet season review, and a provision for a reserve area. Mr. Haggard stated that If a bed and breakfast use were being proposed in the future, it would require further Health Department review as this permit is for residential use only. He presented a letter to the Board from the applicants withdrawing their special use application.

Gary Smith, Septic Design Services, Anacortes, a certified septic designer in Skagit County, addressed the points of the appellants. Mr. Smith reviewed his memorandum given to the Board, noting that the



County Code does not require a wet season review, and that a soils evaluation was done and showed there is far more adequate soil than required. He next discussed that there are adequate setbacks as show in the as-built drawing. He indicated that physical examination of the property clearly shows where the drainfield is located due to the disturbance of the natural vegetation. Mr. Smith indicated that the Health Department did visit the site, reviewing for setback adherence and slope consideration. He also commented that soil log holes were dug and that a reserve drainfield area was specified. Mr. Smith indicated that the plans were approved by the Health Department after appropriate review, adjustments and conditions. Such plans were reviewed with Greg Geleynse of the Planning Department on-site.

Mr. Smith indicated that the septic permit was issued for purposes of residential use.

Mr. Smith next commented on the remarks concerning the effluent running down hill. He stated that the unit proposed meets the standards of a sand filter system, and justifies the doubling of the hydraulic loading rate. He stated that all septic systems have a susceptibility for failure. He commented on the system's maintenance requirements and that the possibility of untreated effluent flowing on the neighbor's property is not probable. He stated that based upon the requirements of County Code, the review and approval of the Health Department, he did not see a problem with this system for residential use.

Mr. Mosher objected to the introduction of a new reserve drainfield area, stating that this information was not given to the Health Officer. Consequently, he did not think this information should be a part of this appeal.

Mr. Mosher reviewed a memo from Mr. Carr dated May 13, 1999.

John Caraba, 11602 North Del Mar, commented on the need for the applicants to follow the same rules he was subject o in the replacement of his home.

Mr. Mosher stated that it is important to identify whether this project is for residential or commercial use. He stated that the applicants have announced their intentions, which are for a congregate living facility. He noted the need to avoid piecemealing the permit process. He stated that the applicants have invested in a commercial establishment, and once they receive this septic permit they will most likely begin operating the bed and breakfast establishment. Consequently, he stated that this septic system will be used for commercial purposes and should be viewed as such.

Mr. Haggard questioned Mr. Smith on whether he submitted the existing drainfield and a reserve area plan. Mr. Smith responded that he submitted a site evaluation plan on May 12, which shows both the existing drainfield and the 100% reserve area, despite the appellant's allegation to the contrary.

Mr. Haggard summarized that this is a narrow issue as to whether Dr. Leibrand, the Health Officer, was arbitrary and capricious in approving the septic tank permit for residential use. He urged the Board to deny the appeal.

Chairman Anderson indicated that the Board would render a decision regarding this matter on July 12, 1999, at 1:30 p.m.

2. <u>Miscellaneous.</u>

There were no miscellaneous items for discussion.

PARKS PROJECTS UPDATE.

David Fair, new Parks & Recreation Department Director, was welcomed by the Board.

A meeting with Jim Chu of the U.S. Forest Service regarding Steelhead Park and Interpretative Study Sites for eagle viewing on Highway 20 was reviewed.

Dennis Lind, Interim Co-Director, gave an update on the progress at the Skagit Valley Dreamfield and the upcoming Grand Opening scheduled for July 31st. He further reviewed the various recreation activities for the month of July including softball leagues, Clear Lake Triathalon, Fastpitch tournaments, Slowpitch tournaments, various camp activities, and the Clear Lake Swim Beach.

Pete Mayer, Operations Manager, discussed the new two-way radio system being activated, and the cost savings to the County. He also spoke regarding the activities of summer interns roving County Parks on Saturdays to check on the condition of the facilities, garbage accumulation, etc.

Mr. Mayer next reviewed recent discussions with the Northern State Recreation Area Task Force, indicating also that a crew has been at the site mowing and chopping tall grass. He stated that such work is being accomplished pursuant to a noxious weed control plan.

Mr. Mayer reviewed activities at the Fair Grounds, and the work being done in preparation for the 1999 County Fair. He stated that the proposal for an indoor soccer facility at the Fair Grounds is awaiting feedback from the proposer, Dennis Sobchuk. He stated that the Sherman Anderson Ballfield acquisition is still a possibility.

Mr. Mayer next reviewed the progress on the updating of the Swinomish Channel Boat Launch. He stated that permit applications are being reviewed by various government entities.

Mr. Mayer spoke regarding the upcoming Northwest Washington Snowmobile Grooming Grant and the efforts of the Department to enhance the grant in cooperation with Whatcom County Parks.

Mr. Mayer discussed the Centennial Trail Highway 9 bridge debris removal and demolition. He also noted that the Public Works Department has been working on developing an environmental response to the Department of Ecology regarding the Cascade Trail. This response will contain an erosion sedimentation plan.

Pressentin Park was briefly discussed, in particular the receipt of plans from Semrau & Lisser and the road prism in relation to archeological issues.

Commissioner Hart commented on the need to hire a Special Projects Manager as discussed previously, to get the person working on many of these "special projects."

CONSENT AGENDA.

Commissioner Wolden moved to approve the Consent Agenda for Tuesday, July 6, 1999, items 1-18. Commissioner Hart seconded the motion, which passed with a unanimous vote.

Ms. Weyer advised that she would review the bids and make a bid award recommendation within the next week or so.

QUARTERLY HUMAN SERVICES DEPARTMENT PRESENTATION.

JoAnne Angevine, Human Services Department Director, spoke regarding Developmental Disabilities, noting that the County had received notice of a 9% increase in funding from the State for the next biennium. She stated that the caseload has stabilized. Currently there are stakeholders within the State who are working as a result of legislation, keeping the institutions with people with disabilities open, while a group of citizens debates the future of such institutions. She indicated that by the end of this biennium there would be a radical change in how we deal with individuals with disabilities.

She reviewed the status of the mental health community, explaining the Regional Support Network with four other counties and the Associated Providers Network. She stated that the contract is secure with APN and RSN for the next year, and for the next two years services will be stabilized. She stated that Community Mental Health has been having difficulties with issues related to union negotiations, and that the possibility of a strike is rather imminent. If a strike occurs, Ms. Angevine indicated that the APN organization will bring in support staff from other communities to handle the day-to-day case management. She briefly discussed the lack of case managers and frontline staff and caseloads growing to unacceptable levels. She stated that the RSN has undertaken a critical urgent review and will look at that question and report back through the Board.

Ms. Angevine indicated that the jail mental health liaison position began in June through County Human Services, working with that person through an oversight committee. She advised that the jail personnel are very pleased that someone is there. She briefly spoke regarding the Children's Crisis Respite Center.

She stated that in February a local oversight committee was initiated for emergency services with people from law enforcement and DSHS for discussing and pulling together to determine what is wrong with emergency services in Skagit County.

Pioneer Center North is adding 50 new beds for involuntary alcoholic treatment to assist with the chronic publicly inebriated individuals.

Vera Sullivan, Substance Abuse Specialist, shared with the Board information about the substance abuse prevention programs, and various funding sources for the 1999-2001. She reviewed the funding streams available to Skagit County including the Office of Public Instruction, CTED, Department of Health, Northwest High intensity Drug Trafficking Area, and the Division of Alcohol and Substance Abuse.

She reviewed the 1997-99 Human Services Prevention Activities. She spoke regarding the SKADU Program and the involvement of 4,000 students in Skagit County. She stated that all of the schools in Skagit County have surveyed their students, with a large enough sample to rely on data received as a result of that survey.

Ms. Sullivan reviewed the 1999-2001 Prevention Plan, commenting on assisting parents during their children's middle school years when children are the most susceptible to drugs.
