The Skagit County Board of Commissioners met in regular session on Monday, December 20, 1999, with Commissioners Ted W. Anderson, Harvey Wolden and Robert Hart present.

CONSENT AGENDA.

Commissioner Wolden questioned the Public Works Department on Item No. 20, a Professional Services Agreement with Skagit Selective Logging, Inc. Mr. Martin explained the particulars of the work to be done. Chairman Anderson questioned the quality and type of logs that would be used for fish passage and other Surface Water Management projects. A previous amount of \$21,000 paid to another contractor was discussed, and Mr. Martin explained the contractual reasons for paying for those logs. Chairman Anderson stated that he would sign the contract with Skagit Selective Logging, but wanted to review the quantity and quality of the logs received. He suggested that if the County cuts top quality trees that perhaps they could be traded for less quality trees for the fish passage projects, thereby getting three or four to one.

After a brief discussion, the Board suggested waiting a week so that they could discuss this contract further with Staff.

Commissioner Wolden moved to approve the Consent Agenda for Monday, December 20, 1999, items 1-19 and 21-22. Commissioner Hart seconded the motion, which passed with a unanimous vote.

MISCELLANEOUS.

1. Vouchers audited and certified by the auditing officer as required by R.C.W. 42.24.080, and those expense reimbursement claims certified as required by R.C.W. 42.24.090, have been recorded on a listing, which has been made available to the Board.

2. Staff presented for the Board's consideration the final Plat of Willard Estates. Commissioner Wolden moved to approve the Plat as presented, and Commissioner Hart seconded the motion. The motion passed with a unanimous vote. Chairman Anderson signed the pertinent mylars of the Plat of Willard Estates.

PRESENTATION BY ECONOMIC DEVELOPMENT ASSOCIATION OF SKAGIT COUNTY (EDASC) REGARDING WASHINGTON COMMUNITY ECONOMIC REVITALIZATION TEAM (WA-CERT) GRANT FUNDING.

Don Wick, Executive Director of the Economic Development Association of Skagit County, reviewed three additional proposals for inclusion on the priority list for the Washington Community Economic Revitalization Team (WA-CERT) Grant Funding. These proposals are:

- Northern State Recreational Area Skagit County Parks & Recreation Department
- Thrifty Intersection Improvements City of Sedro Woolley
- Bayview Ridge Urban Growth Area City of Burlington.

After a brief discussion Chairman Anderson suggested adding these projects as items 7, 8 and 9 on the priority list. Commissioner Wolden moved to place the Thrifty Intersection Improvements as No. 7, the Bayview Urban Growth Area as No. 8, and the Sedro Woolley Playfields at Northern State Property as No. 9. Commissioner Hart seconded the motion, which passed with a unanimous vote. (Resolution No. 17697)

<u>PUBLIC HEARING – TO CONSIDER TESTIMONY REGARDING THE PROPOSED FORMATION OF SKAGIT COUNTY LAKE MANAGEMENT DISTRICT NO. 2 FOR LAKE MCMURRAY.</u>

Jennifer Aylor, Assistant Surface Water Management Division Manager, reviewed a brief history of the formation of the proposed Lake Management District for Lake McMurray. She reviewed a summary of the ballot results and the proposed assessments. She also reviewed the pertinent State Law regarding the formation of Lake Management Districts. She discussed the next steps to be accomplished once the Lake Management District is formed.

Ms. Aylor advised that another public hearing will be held to confirm the fees to be assessed and that a Citizens Advisory Committee will be formed to make further decisions regarding the activities of the Lake Management District.

Chairman Anderson opened the public hearing.

Glen Kensmore, 23243 State Highway 9, stated that he is opposed to forming the lake management district because there are too many unanswered questions. He stated that he did not contribute to the problem, and did not feel he should be paying to get rid of the problem. He indicated that the problem should be taken care of from State fishing license fees.

Larry Fladeboe, 23113 Highway 9, stated that the process is moving too fast, as the materials for removing the milfoil have already been ordered. He commented that there needs to be more community involvement.

Ron Ross, 22128 State Route 9, Cabin No. 25, stated that he does not represent Norway Park, but was present as an individual. He indicated that many people want to get the lake cleaned up, but that the proposed method is not proper. He stated that there have been quite a few public meetings, but no Minutes have been taken. He spoke regarding the inequity of the assessment in regards to the State, and that people without boats are being taxed when they are not causing the problem.

Don Gordon, 23191 Highway 9, Mount Vernon, asked what the result would be from this public hearing, and urged the Board to not delay their decision regarding the formation of the Lake Management District. He commented on the need to do this as a group and pool resources and make local decisions to clean up the lake.

Betty Kite, Mount Vernon, stated that she is against the formation of the Lake Management District and stressed the need to explore different methods for controlling the milfoil. She asked that the people around the lake be informed when the herbicide would be introduced to the lake so that they can take appropriate actions.

Chairman Anderson stated that Mrs. Kite's request was very reasonable. He also explained that there will be a citizen's advisory group formed to make the decisions regarding the most efficient application of herbicide.

Commissioner Hart commented that a lake management district sunsets after 10 years.

There being no further public testimony forthcoming, Commissioner Wolden moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously. The public hearing was closed.

Commissioner Wolden stated that this has been a long onerous process that should have been completed two years ago. He commented that it would have been more appropriate to have had an advisory committee from the lake residents formed at the beginning of this process. Commissioner Wolden indicated that the formation of the Lake Management District has been a desire of the people in the community, and that their chosen advisory committee should decide how to treat the lake. The advisory committee will drive the process, not the County, as the County does not advise special taxing districts how to operate.

Commissioner Wolden moved to support the vote of the residents of Lake McMurray and to create Skagit County Lake Management District No. 2. Commissioner Hart seconded the motion, which carried unanimously. (Resolution No. 17698)

ADJOURNMENT.

Chairman Anderson made a motion to adjourn the proceedings. Commissioner Wolden seconded the motion and it passed unanimously.
