The Skagit County Board of Commissioners met in regular session on Monday, April 10, 2000, with Commissioners Harvey Wolden, Robert Hart and Ted W. Anderson present.

PUBLIC COMMENT PERIOD.

Commissioner Hart was absent for this agenda item.

Jack Cross, Citizens to Save Pilchuck Creek, 3405 North Shore Drive, Mount Vernon, stated that he is aware that the Board has authorized \$35,000 to the Parks & Recreation Department for a survey of the proposed shooting range. He listed the budget cuts that were made for the 2000 budget, and stated that it is a bad idea to continue funding a project which benefits only a small percentage of Skagit County residents. He stated that no cost analysis has been done and it is unknown how much money would eventually be spent. He commented on lost timber revenue for the proposed site. He asked the Board to terminate the project before more County funds are wasted.

CONSENT AGENDA.

Commissioner Hart moved to approve the Consent Agenda, except for Item No. 2 which was not yet completed, and a correction on Item No. 20, changing a typographical error on the bid award from Pacific North Equipment to Smith Tractor. He clarified that the motion was to approve items 1 and 3-21, with the aforementioned correction to number 20. Commissioner Anderson seconded the motion, which passed with a unanimous vote.

3. Resolution Appointing Charles Lorenzo Murray as a County Designated Mental Health Professional as of January 1, 2000. **(Resolution No. 17829)**

Resolution and Interlocal Agreement with the Concrete School District #11 for construction of football and track and field facilities wherein the County agrees to pay the sum of \$76,500 to the District, with the amount of \$38,250 being paid in the Year 2000. The lower bid of \$179,977.35 which was submitted by Pacific Utility Equipment Company, did not meet the specifications of the County for steering, dozer blade, auxiliary hydraulic circuits, linkage style hydraulic thumb or minimum rotation. The bid of \$157,601.41, which was submitted by Pacific North Equipment, did not meet the needs of the County for steering or wheel lean. (Resolution No. 17834)

Joint Funding Agreement with the U.S. Geological Survey, U.S. Department of the Interior to operate and maintain the gauging stations on the Sauk and Skagit rivers during the period October 1, 1999 through September 30, 2001. - Staff presented, on behalf of the Sheriff's Office, a Vendor Services Agreement with Extraditions International, Inc. wherein contractor will take custody and provide secured transportation of prisoner Mitchell Marvin Anfield from Middlesex County Jail in Cambridge, Masachusetts, to Skagit County Jail for a total cost of \$2,151.80. Commissioner Hart moved to approve the Agreement as presented, and Commissioner Anderson seconded the motion. The motion passed unanimously. (Contract No. 04856)
- 3. Tom Sheahan, Director of Emergency Management, reviewed with the Board the need for Emergency Management to move out of the Bayview Shop. He explained that the Department stores blankets and other miscellaneous equipment in one corner of the Shop, in an area approximately 30' x 30'. He suggested that perhaps a small area could be set aside in the old Maintenance Shop for this use. Commissioner Anderson indicated that perhaps Emergency Management could take over the space that was previously occupied by parts and other equipment. Chairman Wolden stated that he would contact Chal Martin to discuss the feasibility of utilizing a portion of the old Maintenance Shop.

CONSIDERATION OF HEARING EXAMINER'S RECOMMENDATION FOR APPROVAL OF AGRICULTURAL VARIANCES FOR:

- 1) Carolyn Lloyd for Property located at 20286 Cook Road, Burlington (AV99-0699); and
- 2) Herald Catlin for property located at 20740 Cook Road, Burlington (AV99-0696)

After a brief discussion on the location of the subject properties and the relationship to the Cook Road Improvement Project, Commissioner Hart moved to approve the two agricultural variances as presented by Staff. Commissioner Anderson seconded the motion. The motion passed with a unanimous vote. **(Resolution Nos. 17835 and 17836**

PROCLAMATION – 128TH ANNIVERSARY OF ARBOR DAY – APRIL 12, 2000.

Commissioner Hart read the Proclamation of the 128th Anniversary of Arbor Day, April 12, 2000. Commissioner Wolden moved to adopt the Proclamation, and Commissioner Anderson seconded the motion. The motion passed unanimously.

Al Craney, District Forester, thanked the Board for the Proclamation for Arbor Day. He stressed the importance of trees in providing oxygen and carbons. He presented the Board with some handouts from the National Arbor Day Foundation.

PROCLAMATION - APRIL 2000 AS DISASTER PREPAREDNESS MONTH.

Commissioner Anderson read the Proclamation into the record. Commissioner Anderson moved to adopt the Proclamation and Commissioner Hart seconded the motion. The motion passed with a unanimous vote.

Tom Sheahan, Director of Emergency Management, reviewed the preparation being done to effectuate preparedness for any emergency in Skagit County.

DISCUSSION WITH HORTICULTURAL PEST AND DISEASE BOARD OF SKAGIT COUNTY.

Alan Merritt, Chairman of Pest Control Board, advised the Board that it was most difficult for the Pest Control Board to come before the Commissioners to ask for money. He reviewed the history of the passage of I-695 and the resultant elimination of pest control funds from the budget. He introduced Steve Sakuma, Todd Gordon and

Jim Perkins who were in attendance. He stated that the Board had a brief meeting with County Administrator, Mike Woodmansee, and Budget/Finance Director Alicia Huschka to discuss their situation. That conversation resulted in the successful reinstatement of some of the monies to the Pest Control Board. He informed the Board that their previous Coordinator had resigned, and now the Board is looking at hiring a replacement. Mr. Merritt stated that the position alone will require all of the money in the budget just to cover wages.

Mr. Perkins spoke to the difficulties in asking the growers to assess themselves more in order to add another \$4,000 to the budget. He reviewed the various amounts that have already been assessed by the growers. Mr. Merrit concurred that the assessments are getting to be too high. He stated that the Apple Commission assessment alone is over \$400 per acre, and that most growers are running at a deficit level. He confirmed that under the language of the apple maggot quarantine, the growers are given stringent requirements to adhere to, and have assessed themselves accordingly to comply.

Allicia Huschka, Budget/Finance Director, advised the Board that the budget currently allocated to the Pest Control. Board is \$16,2000, which is the same funding level as 1999.

Commissioner Wolden suggested that perhaps the Pest Control Board could utilize the County Summer Hire program, if a qualified horticultural student could be found. The salaries of the Summer Hire program would be paid from a different fund, and would not be deducted from the Pest Control Board's budget.

A discussion about the particulars of utilizing the County Summer Hire Program ensued.

Mr. Merritt noted that the time period for the pest control functions is June 1 through the first week of October, and that it may be difficult to utilize a college student through the end of the project.

Mr. Sakuma stated that no matter how the budget is looked at, there is still a shortfall of \$4,200 that must be made up somewhere.

Commissioner Anderson indicated his approval of dedicating two summer hires to this project. He stressed the need to have someone in charge who is credible and can make sure the program is kept on course.

Mr. Sakuma concurred with Commissioner Anderson's comments, stressing the need to maintain the credibility of the program. He indicated that if the west side growers are not seen as being credible, they will eventually have no place to take their product. He stated that they would be willing to participate in a training program, but their biggest concern is not to lose the credibility of the entire program.

Commissioner Hart suggested that perhaps a retired pest inspector might be willing to take charge of the project for the few months it is up and running.

Commissioner Anderson indicated that he would be willing to dedicate one of his summer hire positions to this program, but asked if there is any possible way of finding the extra \$4,200 in the County's budget to assist the apple growers. He explained that his overriding concern is that agriculture in the valley is under siege. He expressed the need to expand the orchard industry by building our own storage facility to protect this industry.

Mr. Perkins acknowledged the efforts of the apple growers and the County in educating the public on the apple maggot problems.

Ms. Huschka indicated that the growers have funded half of the program, and that the additional \$4,200 could be found to assist the growers in this year's program.

Commissioner Anderson summarized that he would be comfortable finding the additional \$4,200 for the program, and exploring ways to utilize summer hires to assist in maintaining the program.

Mr. Perkins stated that the growers have come in under budget every year, and this fact was confirmed by Ms. Huschka. Mr. Perkins stated that they would not spend the extra money unless they absolutely have to.

ADJOURNMENT.

Chairman Wolden made a motion to adjourn the proceedings. Commissioner Hart seconded the motion and it passed unanimously.
