PUBLIC COMMENT PERIOD

Tom Solberg brought in a video tape for the Board to look at that exposed the salmon slaughter that is currently happening at the Samish Fish Hatchery. He reported that last year about 7,000 Chinook were clubbed and sold for pet food. This year the harvest is expected to yield 10,000 fish. The small dam, which was built in 1895, prevents the Chinook from going up-stream and spawning.

Chairman Anderson asked why the native Chinook salmon were not weeded out and deposited on the other side of the dam so they could go up-stream and spawn.

Mr. Soldberg replied that it is because the fins of the fish do not get clipped, therefore, the wild stock and the hatchery fish all blend in. He stated it was not all about the fish. It is also about the required land buffers due to the lack of fish. However, Mr. Solberg said that after viewing the tape, it is hard not to notice that there are plenty of fish.

DISCUSSION/POSSIBLE ACTION – RESOLUTION TO REQUIRE
APPLICANTS FOR PERMITS AFFECTED BY THE GROWTH MANAGEMENT
HEARINGS BOARD'S FINAL DECISION AND ORDER (FDO) IN CASE NOS.
00-2-0046C AND 0-2-0049C TO SIGN WAIVERS AND HOLD HARMLESS
AGREEMENTS WITH THE COUNTY AS A CONDITION FOR THE COUNTY
TO PROCESS THEIR PERMIT APPLICATIONS

John Moffat, Prosecuting Attorney, presented a Resolution to the Board for possible action.

On February 6, 2001, the Western Washington Growth Management Hearings Board (GMHB) issued Final Decisions and Orders(FDO) in Case Nos. 00-2-0046c and 00-2-

0049c relating to County actions in Ordinance No. 17938, adopted July 24, 2002, which among other things, implemented the Unified Development Code (UDC) which adopted new land use regulations in the Skagit County Code. In those FDOs, the GMHB found various provisions of Skagit County's UDC non-compliant with the Growth Management Act (GMA 36,70A). Skagit County was ordered to take action to amend the non-compliant UDC regulations within certain time periods

In response to the FDOs, Skagit County, with respect to some of the regulations found non-compliant, adopted new ordinances to amend the regulations found non-compliant by the GMHB; with respect to other non-compliant regulations the County did not adopt amendatory regulations but instead appealed the FDOs; and the respect to yet other non-compliant regulations the County has remanded proposed changes to those regulations back to the Planning Commission for further review.

The County's appeals are currently pending in Skagit County Superior Court and are scheduled for trial in January of 2002. In light of the potential liability to the County of processing applications based on regulations found non-compliant by the GMHB but which were not amended during the remand period, and recognizing the interest of permit applicants to move forward with their plans, therefore be it resolved that the Planning and Permit Center afford to applicants for permits affected by regulations found non-compliant by the GMHB FDOs and not amended within the remand period the option either to:

- Defer all permit processing of these applications until the uncertainty is resolved by the County's pending court appeals or;
- Agree to processing of the permit applications pursuant to previous applicable code provisions, subject to the applicant signing a waiver of any right to bring a claim for damages against the County as a result of processing the applications under such earlier regulations.

The Resolution shall take effect immediately and shall apply to all applications currently pending in the Planning and Permit Center.

Commissioner Munks motioned to approve the Resolution and Commissioner Dahlstedt seconded, which passed unanimously. (Resolution No. 18444)
