David Wilder, President of the local chapter of People First in Skagit County, discussed the Legislative Reception that is taking place on Saturday, January 26, 2002 from 4 p.m. to 6:00 p.m. at the Skagit Valley College Cafeteria. The reception will deal with disability issues, including housing, transportation, employment, and health needs.

Mr. Wilder said this is the second annual Legislative Reception held in Skagit County. This is the first time all counties in region three have received invitations. Transportation is a huge issue for people with disabilities. That is one of the main reasons for not gathering in Olympia. The Commissioners have been invited as well as other legislative officials.

Mr. Wilder added that anyone with any issues whatsoever, is invited to attend. It is open to the public and it might be especially interesting for businesses who may have questions regarding the Americans With Disabilities Act. An information booth will also be provided.
