The Skagit County Board of Commissioners met in regular session on Monday, December 9, 2002 with Commissioners Don Munks, Kenneth A. Dahlstedt and Ted W. Anderson present.

Mr. Howard advised that the bids would be reviewed and a bid award recommendation would be brought forward within the next week or so.

# PUBLIC HEARING – TO CONSIDER TESTIMONY REGARDING FINAL ADOPTION OF THE 2003 BUDGET FOR SKAGIT COUNTY.

Gary Rowe, County Administrator, outlined the current budget situation and what the forecast looks like for the next five years, which was included in the preliminary 2003 annual budget. He said it was important to remind everyone that the forecast for revenues over the next five years has declined due to the increase in property taxes being limited to one percent. Together with the economy the way it is, the County hasn't seen growth in other revenues to keep up with the demand. He explained that the County needs to be concerned about what happens to Washington State. It is known that we can anticipate a decrease in state revenues when the legislators convene again in January. With those things in mind, it is easy to see that we show a forecast of a decline in growth of revenues, with the overall growth being less than three percent for all the different revenues, including taxes for the general fund. At the same time, expenditures are anticipated to grow just under five percent for the same time period, based on the current economic situation. The primary area of growth in expenditures is in salaries and benefits and with that type of gap you can conclude that cuts will be faced in the ensuing years.

Mr. Rowe stated that the fortunate situation for the County is that we have a reserve that will help offset those decreases over the next several years. Assuming the County can set some policies and direction that can keep the balance between revenues and expenditures from widening, we should be able to maintain a minimum reserve that would prevent the County from getting themselves into financial trouble. Those policies that would have to be seriously considered are what types of staffing levels we are going to have and how to deal with capital expenditures. These are items that when combined together make a big difference in what is available for expenditures. The good news for 2003 is that we have a budget that is balanced between revenues and expenditures for the current situation, that doesn't require us to use our reserves to a great degree.

Mr. Rowe proceeded to explain a few specific issues regarding 2003 supplemental budget requests. He indicated that \$200,000 of the \$686,385 requested from Information Services, would be used for the upgrade of the Cayenta financial system. In addition, \$150,000 of the \$271,526 requested from the Planning & Permit Center would go toward County subarea plans. Applications for subarea plans must be submitted in order to apply for those funds. He feels it is an important issue that the Board needs to be proactive on.

Mr. Rowe stated that several other issues also came up in the process of reviewing the final budget. The list of requests for hotel/motel tax monies totaled \$80,000. The Board will have to decide who gets what as there is only \$54,300 available. The Treasurer is very concerned that their investment interest was increased by \$300,000. Because the County has been conservative on timber sales for the Department of Natural Resources trust lands, Mr. Rowe feels it should all work out.

Chairman Munks opened the public hearing.

Joanne Austin, Cooperative Extension, spoke about her request to have Skagit County pick up the lost funding for her position, which was previously provided by Island County in the amount of \$7,322. Several people spoke in support of Ms. Austin and the valuable programs that she is involved with.

Robert Vaux, Parks and Recreation Director, discussed the need for \$50,000 to conduct an update to the comprehensive plan. It hasn't been done for some time and it needs to be started soon for completion by the end of 2003. He also explored the possibility of a partial allotment of the request. That money would then be used to begin developing a survey asking what County residents desire.

Mr. Vaux also announced that the Fair Advisory Board has secured a Department of Agriculture grant of \$20,000, which requires a match of the same amount. It would be used to provide some much needed pavement work at the fairgrounds. The work would need to be completed by June for the opening of the Skagit County Fair.

Commissioner Anderson suggested that he contact Mr. Rowe to work out the details.

Carol Ehlers, Fidalgo Island, spoke about funding for subarea plans. Commissioner Anderson stated that Mr. Rowe had already indicated that \$150,000 would go toward subarea plans. She proposed several ways to save money in proceeding with those plans. Ms. Ehlers also seconded Mr. Vaux's proposed update on the Parks and Recreation Comprehensive Plan.

As there was no further public testimony forthcoming, Commissioner Anderson motioned to close the public hearing. Commissioner Dahlstedt seconded the motion and the public hearing was closed.

The Board said they would review the 2003 budget further and truly appreciated the synopsis that was provided by Staff.

John Moffat, Civil Attorney, spoke to the Board about filing an amicus curiae brief in support of the Snohomish County petition to the Supreme Court appealing the 9th Circuit Court of Appeals decision in Gobin v. Snohomish County. The decision restricts local land use regulatory authority over Indian lands. The estimate cost for preparing the brief is anticipated to be \$5,000 and is to be prepared by Groen, Stephens, and Klinge LLP. Commissioner Anderson motioned to file an amicus brief as outlined by Mr. Moffat. Commissioner Dahlstedt seconded the motion, which was unanimously approved.
- 3. Staff presented a Resolution reversing the Hearing Examiner's Order Granting Motion to Terminate Review and to remand for further proceedings of Special Use Permit Application No. PL97-0205 Frailey Mountain Shooting Range. Commissioner Dahlstedt motioned to approve the Resolution as outlined. Commissioner Anderson seconded the motion, which passed unanimously. (Resolution No. R20020421)

- 4. Brad Whaley, Finance Director, reviewed a Resolution to authorize a Call for a Public Hearing for a supplemental budget for 2002. The public hearing will be held on Monday, December 23, 2002 at 10:00 a.m. Commissioner Dahlstedt motioned to approve the Resolution as outlined by Mr. Whaley. Commissioner Anderson seconded the motion, which passed unanimously. (Resolution No. R20020422)
- 5. Mr. Whaley next reviewed a Resolution authorizing a Budget Line Item Change to Current Expense Fund #001 in the amount of \$181,019 and the Senior Services Fund #118 in the amount of \$2,020. Commissioner Dahlstedt motioned to approve the Resolution as outlined. Commissioner Anderson seconded the motion, which passed unanimously. (**Resolution No. R20020423**)
- 6. Mr. Whaley outlined a Resolution to accept recommendations of the Economic Development Public Facilities Project Advisory Committee for projects submitted in October 2002. The recommendation is for the City of Anacortes' Downtown Improvement Project for a total of \$70,000 to be funded from the Rural Distressed County sales tax. Commissioner Dahlstedt motioned to approve the Resolution as outlined. Commissioner Anderson seconded the motion, which passed unanimously. (Resolution No. R20020424)
