The Skagit County Board of Commissioners met in regular session on Monday, February 24, 2003, with Commissioners Kenneth A. Dahlstedt, Ted W. Anderson, and Don Munks present.

# PARKS & RECREATION PROJECT PRIORITY UPDATE.

Bob Vaux, Director, conducted the annual Parks and Recreation staff and Parks and Recreation Advisory Board joint presentation to the Board. Mr. Vaux cited recent accomplishments of the department, such as the completion of the Stan Poppe Field renovation; Howard Miller Steelhead Park playground equipment installation, including upgrades to the water and electrical systems; and the opening of the Swinomish Channel Boat Launch.

Mr. Vaux stated that current facilities that are in the process of being finished and renovated are the Howard Miller Steelhead Park Shelter replacement; Clear Lake Beach improvements; Custer Field renovations at Skagit Valley Playfields; and lighting repairs at the playfields, as well. He is also seeking support of the Board to move forward with a 2003 Real Estate Excise Tax request that includes: \$100,000 for the Clear Lake improvements and \$40,000 for the Skagit Valley Playfields lighting.

Patrik Dylan, Parks staff, listed other new, high priority facilities that are currently being considered, including the Northern State Recreation Area, reconveyance of Department of Natural Resources land for the Frailey Mountain Gun Range; Pressentin Park; Conway Park and Boat Launch; Skagit Valley Dream Field lights, restrooms and concession stand; and an indoor recreation center.

Mr. Vaux indicated that he will continue to work with the San Juan Preservation Trust in order to secure private property adjacent to Sharpe Park on Fidalgo Island. The 37 -acre site, known as the Sare's Bluff project, would become an addition to Sharpe Park. Mike Cooper of San Juan Preservation Trust reported that this piece of property is currently the largest piece of undeveloped waterfront property on Fidalgo Island. He stated that any contribution of County funds shall be contingent upon successful fund raising by the Trust and then a transfer of the Sare's Bluff property to Skagit County would take place, with acceptable easement conditions.

Commissioner Munks motioned to approve the sum of \$57,000, which will be contributed by Skagit County through Fund 352 Park Acquisition, to fund raising efforts being done by San Juan Preservation Trust. Commissioner Anderson seconded the motion, which passed unanimously.

Keith Magee, newly elected Chairperson for the Parks & Recreation Advisory Board, introduced other Board members to the Commissioners. He indicated that the Advisory Board has worked with staff to develop the aforementioned priorities and is strongly supportive of them.

The special election will be held on Tuesday, April 22, 2003. The Skagit County Auditor has been requested to conduct the election by mail-in ballot. Commissioner Anderson motioned to approve the Resolution, as outlined. Commissioner Munks seconded the motion, which passed unanimously. (Resolution No. R20030054)

#### PUBLIC COMMENT PERIOD.

Robert Lakey, Seattle, handed the Board a copy of an email he had recently sent them regarding his property at Lake Cavanaugh. It involves the Department of Natural Resources' efforts to log property above him. He said he is not against logging, however, he would like to see it done in a sensible manner to make sure all stormwater concerns are addressed. DNR states that the logging area is County trust lands and indicated to Mr. Lakey that the Board of County Commissioners are the only ones that have a say as to what is done on the property. He asked for the Board's support on this matter.

Several members of the audience spoke out against a proposed lot aggregation rule that was supposedly leaked to the public after it was presented to the County's Hearing Examiner. The Board assured everyone that lot aggregation discussions are ongoing and before anything is approved, everyone will be able to voice their opinions during a public hearing.

#### PROCLAMATION – FFA WEEK IN SKAGIT COUNTY, FEBRUARY 17 -21, 2003.

Chairman Dahlstedt opened the meeting.

Michael Kannely, President of the Mount Vernon Chapter of Future Farmers of America, spoke about activities that his chapter participates in. He is on the Parliamentary Procedures team, as well as being involved in many other projects.

Other members of the Mount Vernon and Burlington chapters introduced themselves to the Commissioners and described various projects and areas that they are active in.

Chairman Dahlstedt thanked everyone for coming and expressed his support for FFA, explaining that he too had been a member, serving as president and treasurer at one time. He said many of his abilities come from that experience and he is very proud of the young people present today.

Commissioner Munks stated that FFA was always a major component in his life as his four daughters were in FFA and he and his wife were leaders. It is a great organization and feels these programs are important to many people.

Commissioner Anderson concurred and said he has always been impressed with the poise and intelligence that the participants show when coming before the Board. He thanked them for their attendance.

Chairman Dahlstedt then read the proclamation declaring February 17-22, 2003 FFA Week in Skagit County and presented the document to the members present.

Commissioner Anderson made a motion to adjourn the proceedings. Commissioner Munks seconded the motion, which passed unanimously.
