The Skagit County Board of Commissioners met in regular session on Monday, February 28, 2005, with Commissioners Don Munks and Ted W. Anderson present. Commissioner Dahlstedt's absence was excused.

PUBLIC WORKS DEPARTMENT - CHAL MARTIN, DIRECTOR

1. Public Hearing – Consideration of Revision of the Six-Year Transportation Improvement Program (TIP) 2005-2010.

Steve Flude, Assistant County Engineer, advised the Board that a revision to the TIP is being made primarily to include an important new project, the Mount Vernon College Way/Riverside Drive Intersection Project. Mr. Flude stated that by adding the project to the TIP, it would have no affect on the County at this time as we would only be partnering with the City of Mount Vernon.

Commissioner Anderson said he is against spending County Road Funds to improve city intersections when there isn't a County road that empties into it.

Chairman Munks indicated that College Way and Riverside Drive are two state highways. While he agrees that it is a heavily used intersection, he doesn't feel the project should be added to the TIP as it would obligate the County to provide funding. Chairman Munks said he doesn't mind supporting the City of Mount Vernon if it were in a minor roll.

Chairman Munks opened the public hearing. There being no public testimony forthcoming, Commissioner Anderson motioned to close the public hearing, which was seconded by Chairman Munks and carried. The public hearing was closed.

Chal Martin, Public Works Director, stated that this is the number one intersection in the County and he doesn't think Mount Vernon can fund it on their own, at least not without help from the County.

The Board suggested to Mr. Martin that he bring the project proposal back when more information is available.

2. Miscellaneous.

- a) Mr. Brookings, Public Works Administrator, said the Department was recently notified by the Northwest Straits Commission of an opportunity to apply for a \$150,000 grant to continue work that the Marine Resource Committee has been undertaking. No match is required for this grant and the funds would be used to pay for administration, education and monitoring. Approximately \$80,000 would be specifically earmarked for restoration work. Mr. Brookings said that with the Board's approval, his Department would send a letter of intent, including a completed application, to the Straits Commission by the end of March.
 - Commissioners Anderson and Munks said they are supportive of efforts to obtain the grant.
- b) Mr. Martin updated the Board on the status of a joint letter signed by the cities, the County, and the dike districts.
- c) Mr. Martin provided a schedule for an upcoming trip to Washington, D. C. for the National Association of Counties 2005 Legislative Conference.

Commissioner Anderson motioned to approve the Consent Agenda for Monday, February 28, 2005, items 1 through 13. Chairman Munks seconded the motion, which passed unanimously.

2. Carly Ruacho, Associate Planner, asked the Board to set a date and time to hear the Planning Commission's Recorded Motion on an amendment to the Skagit County Parks Comprehensive Plan.

Commissioner Anderson motioned to authorize a public meeting on March 22, 2005, at 10:00 a.m., to review the Planning Commission's recommendation on an amendment to the Parks and Recreation Comprehensive Plan for Skagit County. The motion was seconded by Chairman Munks and carried.

PUBLIC COMMENT PERIOD.

Scott MacMurchie, 15255 South Blanchard Road, said a large portion of Colony Creek runs through the middle of his farm. Due to this, his driveway is ruined and he is concerned because the property is subject to severe flooding. Mr. MacMurchie feels a bigger culvert should be installed to prevent any further damage.

Chairman Munks said he would contact the Public Works Department and arrange a meeting to discuss the issue, which would include Mr. MacMurchie and himself.

Thomas Wake, Blanchard, also spoke of the flooding situation at Colony Creek. He feels that the deterioration of the gates should be addressed sooner rather than later. Mr. Wake said it bothers him to see his neighbors so stressed about this issue. He said it would be a shame if the Board doesn't take preventative action very quickly to solve the problems once and for all.

Chairman Munks said concerns have been addressed with areas lying even beyond Colony Road. Although a compromise has been reached regarding the tidegate issue, Chairman Munks said he is hopeful that staff will continue to find a resolution that all property owners can agree on.

Lynn Lennox, Blanchard, asked the Board if there was any likelihood that there would be a resolution by June of 2005. She said the timing for the project is critical at this point.

Chairman Munks replied that he wasn't sure what the timeframe would be on the project; however, Natural Resource Lands Policy Administrator Tom Karsh has been checking on self-regulating tidegates and is optimistic that all of the problems are in the process of being resolved.

Mike Youngquist, Mount Vernon, asked the Board if they would agree to sign a 2005 Community Development Block Grant (CDBG) Planning-Only Grant Pre-Application. Mr. Youngquist stated that counties would contract with the Washington State Farmworker Housing Trust to conduct a survey of farmworkers to determine their housing needs and preferences. The survey would be conducted in Yakima, Benton, Franklin, Grant, Chelan, Douglas, Okanogan, Adams, Walla Walla, Skagit, Whatcom and Snohomish Counties, where 92% of the State's farmworkers are employed.

Mr. Youngquist also asked the Commissioners if Skagit County would be willing to join Chelan County in sponsoring the proposal. He said that in the event Skagit County agrees to partner with them, the

Community, Trade and Economic Development (CTED) would increase the amount of the award for the project, from \$15,000 to \$45,000.

Commissioner Anderson said he has been very supportive of farmworker housing for some time and said he thinks this project is worthwhile. Chairman Munks concurred.

Mr. Dennis indicated that a specific pricing list will be available to the public.

PUBLIC HEARING – PLACEMENT OF A PROPOSITION FOR THE CREATION OF A RURAL PARTIAL-COUNTY LIBRARY DISTRICT WITHIN THE UNINCORPORATED AREAS OF THE ANACORTES, BURLINGTON-EDISON, CONWAY, MOUNT VERNON, AND SEDRO-WOOLLEY SCHOOL DISTRICTS ON A SPECIAL ELECTION BALLOT.

Gary Rowe, County Administrator, stated that on November 12, 2004, the Skagit County Auditor received a petition from residents within the unincorporated areas of the Anacortes, Burlington-Edison, Conway, Mount Vernon, and Sedro-Woolley School Districts, requesting that a proposition be placed upon the ballot for the formation of a rural partial-county library district, in accordance with RCW 27.12.040.

An Affidavit of Sufficiency, dated January 4, 2005, verified that the petition contained the signatures of more than 10% of the registered voters within the area proposed to be included in the rural partial-county library district. Mr. Rowe said the issue before the Skagit County Board of Commissioners is whether or not to place a proposition on the April 26, 2005, Special Election ballot, which would be conducted by mail. Mr. Rowe advised the Board that they should review the proposed boundaries, which could be adjusted if deemed necessary; however, if that were to occur, another public hearing would need to be scheduled.

Chairman Munks opened the public hearing.

Ken Winkes, 18562 Main, Conway, stated that most statewide residents are served by libraries, with the exception of approximately 55,000 people. Of that number, 37,000 live in Skagit County. Mr. Winkes said that could very well be the reason why almost 3,000 folks signed a petition for a rural partial-county library district. He discussed the plan, proposed boundaries, a proposed sample budget, examples of databases, and additional benefits. He also noted that this is a three-phased approach, which encompasses initiation, integration and implementation. Mr. Winkes reported that there is countywide support of the partial-county library concept and eventually, city libraries would share existing materials and online resources.

Eldeen Simmons, 865 Peterson Road, Burlington, asked if the new property tax would be applicable to only those living in the new district or would it be a tax that would apply to everyone.

Mr. Rowe indicated that the property tax would be on all properties located within the five school districts.

Ms. Simmons said she called four libraries to obtain information regarding charges for library cards for non-city dwellers. She said it appears that the public would be paying less for a card than they would for taxes. Ms. Simmons said she doesn't feel it is right that people who have undeveloped property in the County would also be responsible for paying additional taxes. Ms. Simmons said she would rather give a library card as a gift to someone that cannot afford it rather than pay increased property taxes.

Sara Holahan, 1511 38th Street, Anacortes, stated that the people who need libraries the most may not be able to afford the fee for a library card. It is the general consensus in the United States that libraries are free and Ms. Holahan said that is simply not the case. She quoted former County Commissioner Bob Hart as saying, "people really don't care where the funding is coming from, they just expect the service." Ms. Holahan said getting our youth to read early in their lives is very important and that is the basis for this tax-supported public library.

Roger Mercer, 16867 Peterson Road, Burlington, urged the Commissioners to provide more information on this ballot measure so the public can determine what exactly is being considered.

There being no further public testimony, Commissioner Anderson motioned to close the public hearing. Chairman Munks seconded the motion, which carried. The public hearing was closed.

Commissioner Anderson asked Mr. Rowe if the Board has the power to set the levy rate. Mr. Rowe said the statutory limit for the library district is a levy rate of 50 cents per thousand. Once the library district is

formed, the County Commissioners are responsible for appointing the Library District Commissioners, which in turn set the levy rate for the library district. Mr. Rowe said that once the levy rate is set it is subject to the 101% limitation of the law.

Chairman Munks said he has read several letters and e-mails that have been sent in, both for and against the proposal. He feels the County is at a point where there needs to be closure with the library issue and that can only be accomplished by a vote of the people.

Commissioner Anderson said he supported the proposal the first time it was put on the ballot and he continues to support the measure. He said the east County folks looked on the measure favorably as well and developed their own library district. Commissioner Anderson said the County has been subsidizing the libraries for several years, in the amount of \$100,000 per year, in order to keep the costs down for library cards. In recent years that amount has been reduced to \$50,000 due to the pinch that everyone is feeling. While he is sensitive to the concerns of the taxpayers, Commissioner Anderson said reading is the key ingredient to education as it helps develop the creative side of a child's mind.

Commissioner Anderson moved to approve a resolution placing the question of a rural partial-county library district within the unincorporated areas of the Anacortes, Burlington-Edison, Conway, Mount Vernon, and Sedro-Woolley School Districts on the 2005 Special Election ballot, to be conducted by mail. Chairman Munks seconded the motion, which passed. **(Resolution No. R20050079)**

ADJOURNMENT.

Commissioner Anderson made a motion to adjourn the proceedings. Chairman Munks seconded the motion, which passed unanimously.
