RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS TUESDAY, FEBRUARY 26, 2008

The Skagit County Board of Commissioners met in regular session on Tuesday, February 26, 2008, with Commissioners Don Munks, Kenneth A. Dahlstedt, and Sharon D. Dillon present.

 - Closed Record Hearing to Review the Hearing Examiner's Preliminary Plat Approval Recommendation #PL05-0216 for the Long "CaRD" Plat of Madalyn Estates

Brandon Black, Senior Planner, presented a vicinity map identifying the site location in the Lake McMurray area. Mr. Black requested the Board schedule a time and date for Board to review the Hearing Examiner's preliminary plat approval recommendation #PL05-0216 for the Long "CaRD" Plat of Madalyn Estates. Mr. Black stated the project proposal includes the division of approximately 26.61 acres into eleven (11) single family residential lots, with associated Open Space, through the Conservation and Reserve Development process.

A motion was made by Commissioner Dahlstedt to approve setting Tuesday, March 11, 2008, at 2:15 p.m. to review the Hearing Examiner's Preliminary Plat approval recommendation #PL05-0216 for the Long "CaRD" Plat of Madalyn Estates. Commissioner Dillon seconded the motion, which passed unanimously.

C. 9:30 a.m. - 10:00 a.m. Presentation - Meals on Wheels March Fundraising

Jennifer Kingsley, Director of Senior Services, announced the fundraising plans for Meals on Wheels, and provided an overview of the successes for 2007.

Ms. Kingsley also discussed the nutrition program funding over the last four years. She went on to say the program's costs have increased by approximately \$200,000 from 2004 and the grant funds for the program are decreasing.

Commissioner Dahlstedt urged Ms. Kingsley to reach out to the Cities in an effort to obtain some additional support.

Ms. Kingsley explained the schedule of events taking place throughout Skagit County in the Month of March. The events include the following:

For the west side of the county, there will be a March for Meals Parade and Celebration on Saturday, March 22, 2008, at 11:00 a.m. The parade begins at Storvik Park and ends at the Fidalgo Center in Anacortes where there will be a lunch and celebration.

The Tour de Fleur event will be held on Saturday, April 5, 2008. Registration will take place at the Cascade Mall between 8:00 a.m. and 10:00 a.m. and the event ends at 2:00 p.m.
