# RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS TUESDAY, OCTOBER 7, 2008

The Skagit County Board of Commissioners met in regular session on Tuesday, October 7, 2008, with Commissioners Don Munks, Kenneth A. Dahlstedt, and Sharon D. Dillon present.

### I. CALL TO ORDER:

Chairman Munks called the proceedings to order at 8:05 a.m.

### II. PLEDGE OF ALLEGIANCE:

Chairman Munks led the Board in the flag salute.

#### III. AGENDA:

- A. \*8:00 a.m. 8:30 a.m. Consent Agenda and Miscellaneous items
- B. 8:30 a.m. 9:30 a.m. Public Works Department James E. Voetberg, Director
  - 1. Presentation Skagit County's Herbicide Program

Andy Shaw, Special Operations Section Manager, explained the vegetation management program and how vegetation must continually be managed to protect the structural integrity of traveled roadways.

Randy Nelson, Herbicide Applicator, said he would like to continue the herbicide management program. Commissioner Dillon stated she is concerned about the application of herbicides in Skagit County. The Commissioners discussed implementing a program to educate homeowners on the proper application of herbicides.

# 2. Miscellaneous

Ric Boge, Surface Water Manager, presented the schedule for the upcoming Flood Awareness Week events, which will commence on October 16, 2008, and continue through October 23, 2008.

Commissioner Dahlstedt read a proclamation declaring October 16, 2008, through October 23, 2008, as Flood Awareness Week in Skagit County.

Jim Voetberg, Public Works Director, reported that one lane on South Shore Drive on Guemes Island has been closed due bank erosion. Mr. Voetberg stated the Public Works Department is working with the residents on Guemes Island to discuss solutions to improving the road.

C. 9:30 a.m. - 9:45 a.m. Decision - Closed Record Appeal Hearing to Review the Hearing Examiner's Decision to Approve Special Use Application No. PL07-0792 for the Continued Operation of a Recreational Vehicle (RV) Appliance Repair

Business as a Home-Based Business 2, Per Skagit County Code Section 14.16.400(4) (c)

Michele Szafran, Senior Planner, outlined the purpose of the Closed Record Hearing.

Commissioner Dillon said Mr. Pape's application indicates that he owns three parcels, P99276, P34750, and P34749. The application indicates that each parcel has a separate legal description and is a separate lot of record. The County's records indicates that P99276 and P34750 have been aggregated by a boundary line adjustment, but there is no evidence in the record that P34750 and P34749 have been aggregated into one lot.

She also stated this raises a question of whether there is evidence in the record to show that the proposed RV repair business will be operated on the lot that the dwelling is located on. She noted the drawings that Mr. Pape submitted with his application indicate that his residence is located on lot P34750 and that the business is largely conducted on the adjacent parcel, P34749. Each one of these two lots is approximately half an acre in size. Because each parcel is located in the AG-NRL zone, each is a substandard lot and development is not permitted unless certain conditions are met. Thus, the record does not establish that Mr. Pape has a development right for P34749. Also, because the lot where the proposed business will operate is separate from the residential lot, there is no dwelling for it to be incidental to.

Chairman Munks stated the use is not clearly incidental to the use of the property for residential purposes.

He said even if Mr. Pape's RV business were not largely conducted on a lot separate from the lot that the residence on, the use is not clearly incidental to the use of the property for residential purposes.

Chairman Munks noted the following:

- The application establishes that the RV parking, proposed shop, and necessary access will use almost 11/2 acres; and
- At 3,000 square feet, the footprint of the proposed repair shop is greater than the footpri of the residence, which is 2,876 square feet. He noted that the application describes the residence as being 3,500 square feet. However, this includes all of the floor space and no just the building's footprint. Its use does not make for a fair comparison. Even if it did, the drawings show that the proposed shop is considerably taller than the residence and will be larger building; and
- 3) The business requires its own septic system with a considerable drainfield; and
  - The drawings indicate that almost half of the property will be consumed by parking. It evel depicts parking for five personal automobiles adjacent to the house. Add to that the eigh
- spaces shown for RV parking and the parking necessary for delivery trucks, customers, a multiple repair vans, the parking demand then far exceeds the demand that is normal for residential area; and
- The RV parking area, which makes up nearly one-third of the combined lots is a clear exterior indication of the business.

Chairman Munks also stated our State Supreme Court has stated that "a business use is the antonym of residential purpose." At a minimum the, to meet the "incidental" requirement, under the County Code, the business must be less intensive than the residential purpose. He said the scale of this business does not meet that standard. It dominates the half-acre residential property and takes up all of the adjacent half-acre lot.

Commissioner Dahlstedt noted the scale of this business falls in the same category as other home-based businesses that have been reversed on appeal.

He went on to say in the last three years, a number of home-based businesses have been appealed on the grounds that they were not clearly incidental to the use of the property for residential purposes. He noted the sense from the County's decisions should be clear. A business does not meet the clearly incidental test when it requires; 1) non-residential levels of parking and traffic; and 2) use of a high percentage of the property; and 3) separate septic systems, and; 4) large-scale buildings.

He also stated each of these factors applies to the proposed business and the conditions that were imposed on the special use permit do not reduce their impact. Nor do they address significant factors that further affect the scope of the proposed business. He said, the conditions do not define "temporary" and there is no restriction on persons living in their RV's while waiting for repairs to be performed. "Temporary," being something other than permanent or perpetual, is an insufficient condition. He indicated it would let someone live on the property in their RV for a week, a monthly, or all summer. He stated there would be no way for the County to enforce such a vague term. In effect, this permit would allow Mr. Pape to operate an RV park on his property. That is not permitted in the AG-NRL zone even it is related to a home based business. He stated applicants must comply with all applicable code requirements, which Mr. Pape's business does not.

Commissioner Dahlstedt found that the Hearing Examiner's decision was clearly erroneous.

A motion was made by Commissioner Dahlstedt to approve Reversing the Hearing Examiner's decision and deny the Home-Based Business 2 Special Use Permit. Commissioner Dillon seconded the motion, which passed unanimously.

  - 1. Discussion/Possible Action Hearing Examiner Rules of Procedure and Mediation Services

Gary Christensen, Planning & Development Services Director, explained the proposal to formally amend the "Rules of Procedure for Hearing" of the Skagit County Hearing Examiner to allow mediation as an option to the land use hearing process.

Wick Dufford, Skagit County Hearing Examiner, and Andrea Vallee, Director

of Mediation Services, said they concurred with the proposal.

A motion was made by Commissioner Dahlstedt to approve amending the Hearing Examiner "Rules of Procedures" as proposed in Attachment A of the Memorandum from Wick Dufford, Hearing Examiner, dated April 14, 2008, and as supported and recommended by Planning and Development Services, Mediation Services, and the Prosecuting Attorney's office. Commissioner Dillon seconded the motion, which passed unanimously.

Mr. Christensen noted a resolution will be prepared and provided to the Commissioners for signature on a future Consent Agenda.

2. Discussion - County Proposal to Address Western Washington Growth Management Hearings Board (WWGMHB) Appeal Items Regarding 2005 Growth Management Act (GMA) Compliance Actions

Carly Ruacho, Senior Planner, provided a brief description of the five compliance issues and recommended corrective actions identified in the Western Washington Growth Management Hearings Board (WWGMHB) Case No. 07-2-0025c relating to an appeal of Skagit County's 2005 Growth Management Act update.

Ms. Ruacho stated Skagit County's Comprehensive Plan and Development Regulations were not in compliance with the Growth Management Act (GMA or the Act) on several matters, and the County has been given 180 days to comply with the GMA. She went on to say the compliance issues principally involve the uses permitted within limited areas of more intensive rural development (LAMIRDs) and potential inconsistencies between the Comprehensive Plan and Development Regulations. She noted the Planning & Development Services Department is accepting public comments, which must be submitted by 4:30 p.m., Friday, October 10, 2008. She also noted there will be a public hearing with the Skagit County Planning Commission on Tuesday, October 14, 2008, at 6:00 p.m. in the Skagit County Commissioners' Hearing Room.

Ms. Ruacho went on to say the Planning Commission is expected to deliberate on October 28, 2008, and their recorded motion will be presented to the Board of Commissioners at a later date.

3. Discussion - Bayview Ridge Subarea Plan - Implementation Phase 1 and 2

Mr. Christensen explained the next planning process for the Bayview Ridge Subarea Plan is to move from the planning concept and ideas to implementation. He stated the Planning & Development Services and Public Works Departments have interviewed three consultants and recommend the firm of HDR to help the County with this task. He went on to say HDR has a local presence with its Burlington office, has a long history of work on Skagit County projects, and with its nationwide offices brings extensive expertise to

implementing the Bayview Ridge Subarea Plan.

He reported in the coming weeks, a scope of work and contract will be forwarded to the Commissioners for review. He stated with Commissioner approval, work will commence this fall.

The Commissioners stated they had confidence in HDR, but they would like to make sure there is a date set for the completion of this project.

Tim Holloran, Skagit County Deputy Administrator and Coordinator for Skagit County Special Olympics, thanked the Commissioners for recognizing October 2008 as Down Syndrome Awareness Month.

Commissioner Dahlstedt read a proclamation declaring October 2008 as Down Syndrome Awareness Month in Skagit County.

The Commissioners recessed the proceedings for lunch at 12:00 p.m.

Marge Swint, Senior Planner, stated the request is to allow for the division of approximately 24 acres into four one-acre lots for residential development and one approximately 14+ acre open space lot. Ms. Swint noted an internal private plat road, onsite sewage, and private wells will serve the project. She went onto to say

the subject property is designated as Rural Reserve. She noted the property is located on Island View Way off of Colony Road in the Bow area.

A motion was made by Commissioner Dahlstedt to approve the final Plat of Island View Court (PL05-05096) submitted the E.C. Trust. Commissioner Dillon seconded the motion, which passed unanimously.

Ms. Swint reported this closed record public meeting is for the final plat approval of the Plat of Cedar Creek (PL06-0742) submitted by Northern Reign Development Co. She sated the proposed plat is the division of approximately 40 acres into nine lots created through the Conservation and Reserve Development (CaRD) process. The proposal includes eight one-acre residential lots and one approximately 29-acre lot designated as Open Space-Recreational/Amenities. An internal private plat road, onsite sewage, and individual wells will serve the project. She went on to say the subject property is designed as Rural Reserve. She stated the subject property is located south of the Mosier Road off Erna, Lane north of Sedro-Woolley.

A motion was made by Commissioner Dahlstedt to approve the final plat of the Plat of Cedar Creek (PL06-0742) Submitted by Northern Reign Development Company. Commissioner Dillon seconded the motion, which passed unanimously.

41. Vendor Services Agreement with AquaTechnex, LLC to provide aquatic vegetation surveys and lake treatment services for Lakes Erie and Campbell (Lake Management District #3). The agreement commenced on July 1, 2008, and shall continue through June 30, 2010. Compensation for this agreement will be funded by annual assessments and shall not exceed \$29,000. (Contract No. C20080579)

### o) SHERIFF'S DEPARTMENT:

42. Leap Service Agreement between the Skagit County Sheriff's Office and NeuStar, Inc. for access to the LEAP Data Elements. The agreement commenced on September 4, 2008, and shall continue through September 3, 2011. Compensation is not to exceed \$50 per subscription, plus \$0.50 per TN. (Contract No. C20080580)
