RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS MONDAY, DECEMBER 14, 2009

The Skagit County Board of Commissioners met in regular session on Monday, December 14, 2009, with Commissioners Kenneth A. Dahlstedt, Sharon D. Dillon, and Ron Wesen present.

I. CALL TO ORDER:

Chairman Dahlstedt called the proceedings to order at 10:00 a.m.

II. PLEDGE OF ALLEGIANCE:

Chairman Dahlstedt led the gallery in the salute to the flag.

III. AGENDA:

- a) *8:00 a.m. 10:00 a.m. Briefing County Commissioners/Administrator
- b) 10:00 a.m. 10:30 a.m. Presentation of Draft Climate Action Plan

Ryan Walters, Sustainability Administrator, was present to brief the Board on the Draft Climate Action Plan. Mr. Walters thanked everyone involved in putting this plan together. Skagit County partnered with multiple agencies to help accomplish the goals of the Climate Action Plan. Mr. Walters reported that countywide recycling has increased, two gas-electric vehicles have been purchased, and the Guemes Island Ferry partially runs on biodiesel. Mr. Walters informed the Commissioners that our neighboring Counties are also participating in Climate Action Initiatives and that Skagit County will be participating in energy efficient updates to buildings. Currently, the County pays approximately \$600,000 a year on electricity. The updates to the buildings will be paid for by the savings from the energy efficiencies. A large part of the Climate Action Plan includes outreach and education to Skagit County staff and to the community. The Green Purchasing Committee found many ways for Skagit County to save money. Various suggestions were made in the Plan including: streamlining permitting of energy conservation projects, appointing an ombudsman in the Planning Department, and reducing permit fees for energy efficiency in new construction. Regarding purchasing: making centralized purchasing, purchasing green, using efficient vehicles, and following integrated pest management practices on county land. Regarding solid waste: eliminating polystyrene countywide, expanding the event recycling program, requiring county events to be zero-waste, improving recycling at county facilities, improving recycling in East Skagit County, providing garbage vouchers to low income residents, and hiring a recycling coordinator. Educating the public and businesses, supporting the Cool Communities Campaign, and creating an internal sustainability committee were also recommended. Regarding Skagit County staff: space heaters would be eliminated in offices, the HVAC system temperatures would be set, air cleaners would be phased out, mini fridges would be eliminated, incandescent bulbs would be eliminated, computers, computer monitors, lights, and certain appliances and equipment would be turned off when not in use. Mr. Walters informed the Board that a public meeting will be held tonight, December 14, 2009, in the Continental Building at 6:00 p.m. to take comments on the Climate

Action Plan. Written comments will be accepted until December 21, 2009. Mr. Walters is estimated that the plan will be completed by the end of this year. For more information, he suggested that people visit the website: www.skagitcounty.net/sustainability.

The Commissioners thanked the Committee and the others involved for working on this project. They stated that this is a wonderful program and are looking forward to implementing it, saving money, and helping our environment. Commissioner Dillon was pleased that the deadline will be met for this project. Chairman Dahlstedt wanted to take a closer look at the plan's proposal regarding the suggestions for the Planning Department and streamlining energy conservation projects. Chairman Dahlstedt would be hesitant to change the current permitting process. The Commissioners thanked Mr. Walters for his work on the project and for his presentation.

Chairman Dahlstedt recessed the proceedings at 10:39 a.m.

Washington State University began the initial study of Skagit County's agricultural economy for the Skagit Alternative Futures Project (C20090148) on March 2, 2009. Due to severe budget cuts by Washington State University, the economist contracted with to perform the analysis was laid off. In order to stay with the Environmental Protection Agency grant timeline, it was necessary to continue work in August with Globalwise, Inc. This Agreement will cover work performed from August 1, 2009, through September 3, 2009. A long-term new contract will be executed to complete the study with a separate consultant chosen from the Planning & Development Services consultant roster in accordance with Skagit County's purchasing guidelines. (Resolution No. R20090508)
- 14. Personal Services Agreement with Globalwise, Inc. for the development of an analysis of Skagit County's agricultural economy for the Skagit Alternative Futures Project. This contract is funded through an Environmental Protection Agency grant. The term of this Agreement shall commence on August 1, 2009, and shall continue until September 3, 2009. Compensation shall not exceed a total of \$16,810. (Contract No. C20090689)
